6 BRIDGE PREVENTATIVE MAINTENANCE) AUTHORIZE THE DEPOSIT OF FUNDS IN THE
PROGRAM SCOUR MITIGATION PROJECT) STATE OF CALIFORNIA - CONDEMNATION
7 DEPOSIT FUND

9 WHEREAS, a public hearing has been set for May 7, 2019, at the hour of 9:00 A.M. or as soon
10 thereafter as practicable, to determine whether a resolution of necessity should be adopted as provided
11 by law precedent to the commencement of eminent domain proceedings to acquire real property
12 interests for the purpose of conducting maintenance activities on twelve (12) bridges, located in the
13 County of Fresno and Kings County, as part of the Bridge Preventative Maintenance Program Scour
14 Mitigation Project, in order to extend the service life of the existing structure at each location by
15 installing new or repairing existing scour countermeasures, hereinafter referred to as "the Project."

16 WHEREAS, said hearing was duly noticed and held before the Fresno County Board of
17 Supervisors (hereafter, "Board") in the manner prescribed by law; and,

18 WHEREAS, it appears that the public interest and necessity requires that certain real property
19 interests be acquired for the Project, upon and along the certain parcels situated in the County of
20 Fresno, State of California, whose descriptions and extent of property required and owners of record
21 are as set forth in Exhibits A and B, attached hereto and incorporated herein by reference; and,

22 WHEREAS, this Board is authorized to acquire certain real property interests by eminent
23 domain pursuant to Government Code Section 25350.5, Streets and Highways Code Section 943, and
24 California Code of Civil Procedure Section 1230.010, et seq.; and,

25 WHEREAS, it appears that it is not possible to acquire the hereinabove property and interests
26 therein by negotiations and that it will be necessary to institute proceedings in eminent domain; and,

27 WHEREAS, it appears that the taking of possession of said certain real property interests upon
28 the institution of condemnation proceedings is necessary to expedite the project; and,

1 WHEREAS, the estimated date of use thereof for such purposes is the earliest date possible;
2 pursuant to Code of Civil Procedure section 1240.220(a), there is a reasonable probability that the date
3 of use of the property will be within seven years from the date the complaint is filed.

4 NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Fresno,
5 with regard to the real property described in Exhibits A and B and the proposed project, hereby finds
6 and determines as follows:

- 7 1. That the public interest and necessity require the proposed Project;
- 8 2. The proposed Project is planned and located in a manner that is most compatible with the
9 greatest public good and the least private injury;
- 10 3. That the certain real property interests described herein are necessary for the proposed
11 Project;
- 12 4. That the offer required by Section 7267.2 of the Government Code has been made to the
13 owners of record of the real property which is the subject of the proposed Project;

14 BE IT FURTHER RESOLVED that the Board of Supervisors of the County of Fresno, as to the
15 interests in the parcels of real property described herein and by the Exhibits hereto which are
16 incorporated by reference, hereby finds and determines that the real property subject to this proposed
17 project is subject to existing public uses, as briefly described below, and that the property herein
18 described is being acquired pursuant to Code of Civil Procedure section 1240.510 for a public use set
19 forth herein which is compatible with the existing public uses. The Board of Supervisors for the County
20 of Fresno further finds and determines that the acquisition and public use herein described of the
21 parcels will not unreasonably interfere with or impair the continuance of the public use as its exists or
22 may reasonably be expected to exist in the future, as required by Code of Civil Procedure section
23 1240.510. The Board of Supervisors of the County of Fresno, further resolves, finds and determines, in
24 the alternative, that the parcels and interests herein described are being acquired pursuant to Code of
25 Civil Procedure section 1240.610 for a more necessary public use. The parcels and interests therein
26 above-described are as follows:

1 As to Parcels 1 and 4, various easements and Right of Way Kings River Conservation District to
2 operate and maintain the Kings River Channel Improvement Project, to construct and repair levees,
3 embankments and canals, and to clear/remove any debris and obstructions from the channel.

4 BE IT FURTHER RESOLVED that the County Counsel of the County of Fresno be, and hereby
5 is, authorized and directed to institute and prosecute proceedings in eminent domain to acquire the
6 hereinabove described real property interests and to secure possession thereof on the earliest date
7 possible. Pursuant to Code of Civil Procedure section 1240.220(a), there is a reasonable probability
8 that the date of use of the property will be within seven years from the date the complaint is filed.

9 BE IT FURTHER RESOLVED that the Auditor-Controller/Treasurer-Tax Collector of the County of
10 Fresno be, and hereby is, authorized and directed to issue checks in the aggregate amount of \$53,400.00,
11 as certified by the Director of Public Works and Planning or designee, made payable to the State of
12 California – Condemnation Deposit Fund and delivered to the Design Division Manager to be placed on
13 deposit for possession upon the institution of condemnation proceedings as provided by law.


