6 AN ORDINANCE AMENDING TITLE 13 – ROADS, PARKS, OTHER PUBLIC
7 PLACES, CHAPTER 13.16 PARKS AND RECREATION AREAS, SECTION 13.16.080
8 VEHICLE ENTRANCE FEE OF THE ORDINANCE CODE OF THE COUNTY OF
9 FRESNO

10 The Board of Supervisors of the County of Fresno ordains as follows:

11 SECTION 1: The Ordinance Code of the County of Fresno is hereby amended by
12 amending Section 13.16.080 to read in its entirety as follows:

13 13.16.080 – Vehicle entrance fee.

14 There shall be a vehicle entrance fee for all County parks as established in
15 Section 1500 of the Master Schedule of Fees.

16 The Director of the Department of Public Works and Planning or designee is
17 authorized to waive the vehicle entrance fee for the following:

- 18 A. Public schools conducting educational or athletic events. The fee may be
19 waived for students, parents, guardians, teachers, officials and support staff.
20 B. Employees of public agencies conducting public business. The waiver may
21 also be extended to contractors or consultants conducting business on behalf
22 of public agencies.
23 C. Persons entering parks for community service projects sponsored by local
24 charitable organizations which directly benefit the parks and immediately
25 surrounding environments.
26 D. The Board of Supervisors may also waive the vehicle entrance fee when in
27 the opinion of the Board the waiving of the fee will provide a direct public
28 benefit.

1 All requests for waivers shall be submitted to the Director of the Department of
2 Public Works and Planning in advance of the requested entrance.

3 All United States veterans and active-duty service members with proof of status
4 as a veteran or active-duty service member are exempt from vehicle entrance fees for
5 all County parks.

6 SECTION 2: This Ordinance amendment shall take effect (the "Effective Date")
7 and be in force thirty (30) days after the second reading hereof by the Board of
8 Supervisors and its passage.
