ORGANIZATION 1500 IN THE AMOUNT OF \$348,250)

WHEREAS, the Inmate Welfare Organization 1500 requires \$348,250 to provide a turnkey software/hardware tablet system to support and benefit the inmates' educational, vocational, religious, health and wellness and cognitive behavioral needs; and

WHEREAS, \$348,250 is available in the fund balance of the Inmate Welfare Fund's Special Revenue Fund 0096, Subclass 17700 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations of the Inmate Welfare Fund Org 1500; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Sheriff-Coroner Organization 1500 as follows:

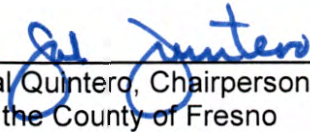
