WHEREAS, the Department of Social Services - Dependent Children -
Foster Care Organization 6410 requires an additional \$868,842 in
appropriations in order to make mandated assistance payments; and

WHEREAS, the Department of Social Services - Dependent Children -
Foster Care Organization 6410 will receive additional revenues in the
amount of \$868,842 in 2011 Foster Care Assistance Realignment revenues;
and

WHEREAS, said monies are not included in the FY 2014-15 adopted
appropriations and estimated revenues of the Department of Social
Services - Dependent Children - Foster Care Organization 6410; and

WHEREAS, Section 29130 of the Government Code provides for the
appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-
Tax Collector is authorized to increase the appropriations in the FY
2014-15 budget of the Department of Social Services - Dependent -
Children - Foster Care Organization 6410 as follows:


