WHEREAS, the Sheriff's Federal Asset Forfeiture Treasury Organization 1466 requires \$75,000 to meet expenditures associated with the costs to purchase an overhauled engine for the Sheriff's airplane; and

WHEREAS, \$75,000 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Subclass 17665 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2019-2020 adopted appropriations and estimated revenues of the Federal Asset Forfeiture Treasury Org 1466; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


