WHEREAS, the County of Fresno is anticipated to received \$1,850,000 from the State of California pursuant to the emergency authority granted to the Governor under the Emergency Services Act and the California Department of Corrections and Rehabilitation (CDCR) Secretary under Cal Penal Code section 2900(b); and

WHEREAS, said monies were not included in the FY 2020-21 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 31114000; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Sheriff-Coroner-Public Administrator Organization 3111 as follows:


