11 WHEREAS, the Code Enforcement – CAO Org 4620 requires \$165,083 to meet  
12 expenditures; and

13 WHEREAS, the Admin Fines – Code Enforcement Org 1188 requires appropriations to  
14 fund an Operating Transfer Out in the amount of \$165,083 to the Code Enforcement - CAO Org  
15 4620; and

16 WHEREAS, sufficient funds are available in Admin Fines – Code Enforcement Fund 0085,  
17 Subclass 17408, Org 1188 FY 2025-26 actual revenues collected to fund these expenditures; and

18 WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and  
19 estimated revenues for Admin Fines – Code Enforcement Org 1188; and

20 WHEREAS, Section 29130 of the Government Code provides for the appropriation of  
21 these funds by a four-fifths vote of the Board of Supervisors;

22 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector  
23 is authorized to establish appropriations in the FY 2025-26 Admin Fines – Code Enforcement Org  
24 1188 as follows:
