This Ordinance to amend the Fresno County Master Schedule of Fees, Charges, and Recovered Costs of the Ordinance Code of the County of Fresno (the "Ordinance Amendment") by amending subsections 4302-4305, 4308-4310, 4313-4315, 4317, 4320-4323, and 4326-4330 of Section 4300 - Information Technology Services, relating to recovery of costs for Information Technology Services and PeopleSoft Operations.
