


## **Proof of Service by Mail**

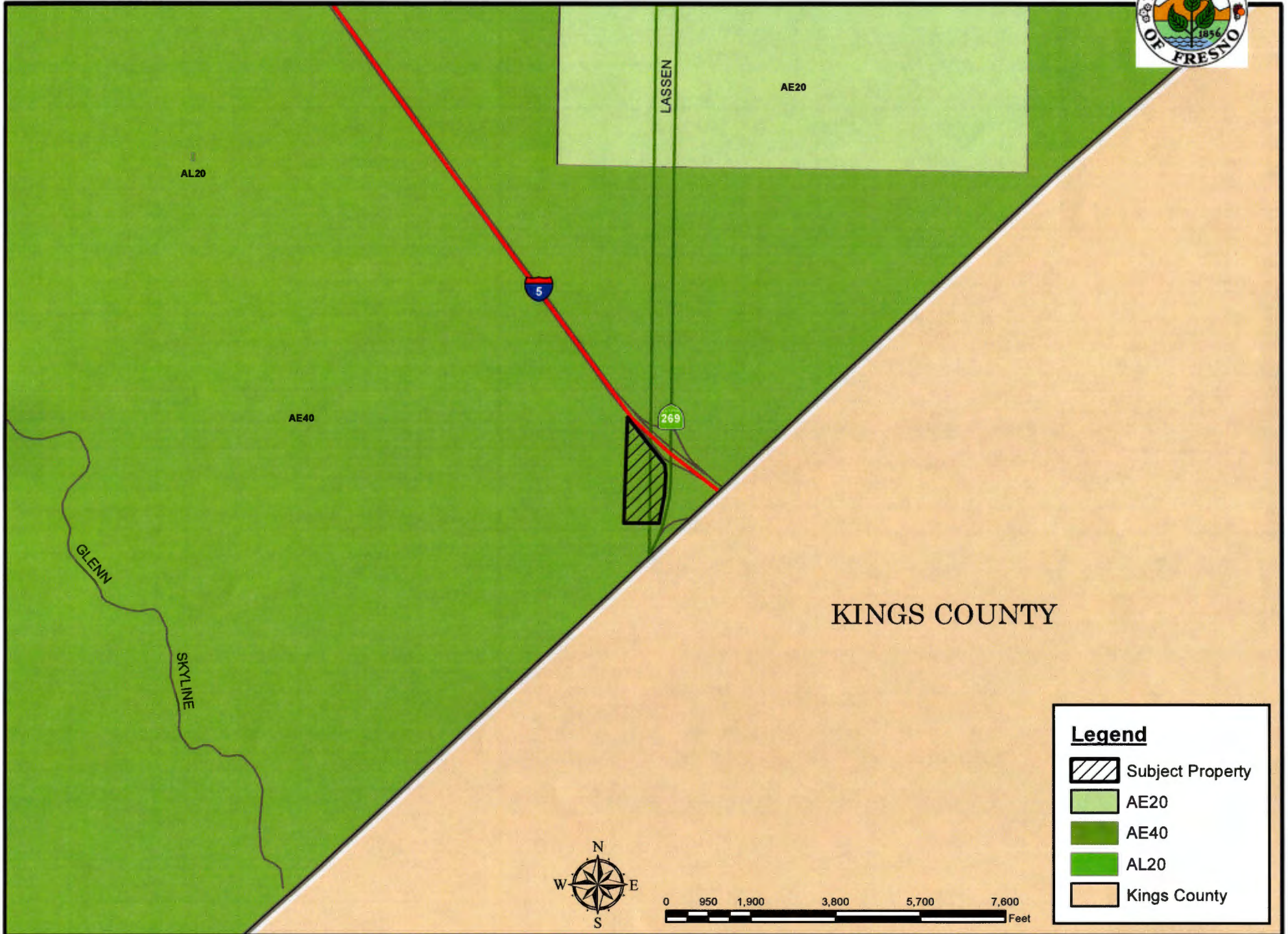
