WHEREAS, the Fresno County Sheriff will receive \$113,284 (\$105,222 – patrol boat and \$8,062 – miscellaneous equipment of inflatable raft/salvage equipment) from the State of California Department of Parks and Recreation Division of Boating and Waterways; and

WHEREAS, said monies are not included in the appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Org 3111 for Fiscal Year 2020-21; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the Fiscal Year 2020-21 Sheriff-Coroner-Public Administrator Org 3111 as follows:


