WHEREAS, the County of Fresno will receive \$623,910 in additional Proposition 172 (sales tax) revenue over budgeted estimates, \$276,090 in additional Prior Year Revenue over budgeted estimates, and \$300,000 from the Federal Asset Forfeiture fund; and

WHEREAS, \$1,200,000 is not included in the appropriations and estimated revenues of the Sheriff's Org 3111 for Fiscal Year 2014-15; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector be authorized to increase the Fiscal Year 2014-15 appropriations for Sheriff's Org 3111 as follows:
