WHEREAS, the Social Services Fund 0065, Subclass 17238, Housing and Disability Advocacy Org 1133 will need to transfer additional revenues of \$26,589 to meet unanticipated expenses associated with Housing and Disability Advocacy for FY 2020-21; and

WHEREAS, said monies were not included in the FY 2020-21 adopted appropriations and estimated revenues of the Housing and Disability Advocacy Org 1133; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Housing and Disability Advocacy Org 1133 as follows:


