Re: Court Order Directing the Board of Supervisors to Vacate Approval of the Update of the Friant Community Plan and the Adoption of the Friant Ranch Specific Plan

Dear Chairman Steve Brandau and Members of the Board of Supervisors:

On February 16, 2021, the Fresno County Superior Court issued an amended peremptory writ of mandate ordering your Board to **promptly** vacate its February 1, 2011 approval of the update of the Friant Community Plan and the adoption of the Friant Ranch Specific Plan. The order also directed your Board to decertify the associated Final EIR.

On February 22, 2021, the County of Fresno (County) filed an objection with the Superior Court stating that the County would need at least 90 days to comply with the amended Order. (The Superior Court did not respond to the County's objection.)

The County gave two reasons why it was infeasible within 30 days of receipt of the amended Order to take the action directed by the Court. The County stated that the Ralph M. Brown Act required public notice at least 72 hours before a scheduled Board meeting and that internal County policies necessitated a minimum of 70 to 90 days to prepare an agenda item.

In an accompanying declaration supporting the County's objection, Assistant Director of the Department of Public Works and Planning Bernard Jimenez explained in detail the County's internal procedures for preparing, circulating and approving Board agenda items. Mr. Jimenez explained that Board agenda items often require the preparation of agreements, resolutions, ordinances, and exhibits; that the County has a 25-day pre-review process to gather comments from various departments; and that the formal review of a Board agenda item includes a review

of fiscal impacts and a check for readability. He added that there were additional formalities associated with the repeal of a zoning ordinance.

What Mr. Jimenez described to the Court were County procedures for processing new project applications — not the process for responding to a court order to set aside a project that has already gone through the approval process. With respect to complying with the Court Order, the County does <u>not</u> need to prepare any agreements or exhibits, route the agenda item through various departments or review fiscal impacts.

What's needed are two rather simple documents: a staff report and a Board resolution. These documents are easily drafted because no new inquiries or findings are needed. In fact, all of the information to be included in the staff report and Board resolution is already in print.

There is no reason why the County cannot comply with the Court Order requiring **prompt** action. I ask the County to place on the Board agenda for March 23, 2021 an agenda item that will enable the Board to vacate approval of the update of the Friant Community Plan, vacate adoption of the Friant Ranch Specific Plan and decertify the associated EIR.

I would like to remind the County that the trial court judge issued a peremptory writ of mandate back in March of 2019, which the County did not contest, so the County has known for almost two years that it would need to vacate project approvals and rescind certification of the EIR.

This letter is in response to your request for a Firearms Eligibility Record Review concerning the existence of records within the files of the California Department of Justice (the Department) used to determine whether you are eligible to own, possess, or purchase firearms. As of the date of this letter, a search of firearms eligibility records maintained by the Department using your personal identifiers did not match any record of those with your personal identifiers.

The purpose of a Firearms Eligibility Record Review is to provide the applicant with a copy of a record maintained and used by the Department to determine the person's eligibility to own, possess, or purchase a firearm. (Pen. Code, sections 11121, 30105.) The Firearms Eligibility Record Review also provides the individual with an opportunity to refute any erroneous or inaccurate information contained in firearms eligibility records maintained by the Department.

A Firearms Eligibility Record Review may not be used for licensing, certification, or employment purposes. It is a crime for anyone to request or require you to provide them with either your firearms eligibility record, or a notification from the Department that no such record exists. (Pen. Code, sections 11125, 30105.) A person who is authorized by law to obtain state summary criminal history information within a firearms eligibility record may not furnish the information to a person who is not authorized to obtain it. (Pen. Code, section 11142.) Furthermore, it is a crime for an unauthorized person to buy, receive, or possess the record or information. (Pen. Code, section 11143.)



Greetings County of Fresno Board of Supervisors,

Central Valley United for Power (CV-UP) is a coalition of eight organizations that builds inclusionary and transformative people power across eight counties. We promote policies and systems that will provide equitable opportunities for working families, youth, and communities throughout the Central Valley.

As you are aware, because of the growth in population from 2010-2020, the boundaries of Fresno County Board of supervisor will require significant change per the 2020 Census. CV-UP ask how the County of Fresno is going to comply with the New Mandates of AB849 Fair Maps Act with regards to transparency and public engagement of the Redistricting of the Board of Supervisor, which includes the following:

 Five public hearings: up to two conduced prior to lines drawing, at least two more held for public inputs and changes after maps have been made public, and one final hearing for adoption of a map that has been made public for 7 days prior to adoption.

In addition, we want to ask:

- Schedule meetings regarding BOS redistricting from 8:30 am until after 6 pm to ensure community participation. Moving forward redistricting conversations be made a special timed item in the agenda to respect community members.
- Create a dedicated portal on the redistricting process. Place explanation of the redistricting process, links to materials, calendar of all public hearings/meetings open to the public on the County of Fresno website homepage.
- Apply Traditional Redistricting Principles in the proper order:
  - Equal Population
  - Compactness
  - Contiguity
  - Preserving Communities of Interest
  - Preserving Local Political Subdivisions and new Census designated places (CDP)
  - As required by this law exclude the home address of incumbents as a consideration in the creation of new board of supervisor lines
- Have demographer available to receive direct input from individuals and/or community organizations to discuss proposed maps. From this input have demographer create community generated maps for consideration.
- Make all data and shapefiles for all proposed maps available for download off the County Fresno website and make the website in Spanish and English.
- Simultaneous Spanish translation by a professional interpreter during the board meetings is a common practice by public boards.
- Translation of all printed materials distributed during board meetings and forums in Spanish.
- Live stream redistricting meetings in remote areas, with the opportunity for real-time participation (testimonies, questions, and/or comments) by community members.

- Preserve video and place on redistricting portal, including the time stamp on the video when redistricting matters are being discussed.
- The specific time designation of redistricting matters on the board meeting agenda to facilitate meaningful community participation.

We look forward to your timely response. Thank you.
