WHEREAS, said monies are not included in the appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Org 3111 for Fiscal Year 2021-22; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the Fiscal Year 2021-22 Sheriff-Coroner-Public Administrator Org 3111 as follows:
