RESOLUTION

WHEREAS, the County of Fresno will receive \$100,000 through the Department of Public Health for Homeland Security grants for the purchase of one Emergency Response Team vehicle; and

WHEREAS, the Department of Public Health Org 5620 has allocated \$100,000 to the Sheriff-Coroner Org 3111 for the purchase of an ERT Response Vehicle; and

WHEREAS, \$100,000 is not included in the FY 2016-17 adopted appropriations and estimated revenues of the Sheriff-Coroner Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

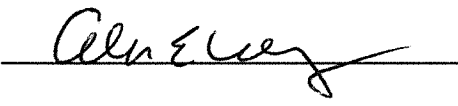

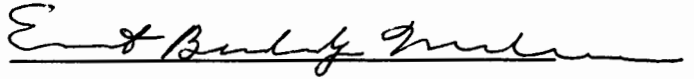

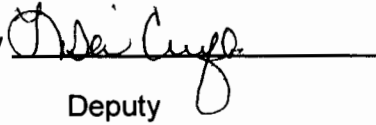
