RESOLUTION

WHEREAS, the Fresno County Sheriff will receive a decrease of \$132,390 from Agreement No. 25-167 in the amount of \$452,764 to the amended amount of \$320,374 for financial aid from the State of California Department of Parks and Recreation Division of Boating and Waterways; and

WHEREAS, the Fresno County Sheriff is estimated to receive \$133,416 from Agreement No. 23-563 from a supplemental grant from the federal Recreational Boating Safety grant in Fiscal Year 2025-26; and

WHEREAS, said monies are not included in the appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Org 3111 Recommended Budget for Fiscal Year 2025-26: and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the Fiscal Year 2025-26 Sheriff-Coroner-Public Administrator Org 3111 as follows:


