SUMMARY OF PROPOSED ORDINANCE

This Ordinance amends Chapter 2.72, entitled "Supervisory Districts," of Title 2, entitled "Administration," of the Ordinance Code of Fresno County by amending Sections 2.72.010, 2.72.020, 2.72.030, 2.72.040, 2.72.050, 2.72.060, and 2.72.070 to provide for the establishment of supervisory districts by ordinance or resolution.
