1. We understand that the "Developer Impact Fee" for Commercial/Industrial is \$.56 / square foot
2. I have contacted the City of Fresno about the intersection of Bullard and Grantland. It is my understanding that the City will be signalizing this intersection in the near future and I will get the timing from them
3. The Traffic Information Study that was completed by JLB Traffic Engineers indicates that the developer of this facility has to install appropriate street improvements in Grantland Ave. and participate (pay their "Fair Share") in the enlargement of the intersection of Grantland and Parkway which is north of the project site.
4. Regarding the "abandoned animal" issue (animals dropped off after operating hours) that your letter references, I will discuss this with the folks who will be operating the facility and see what kind of "solution" we can come up with. I will get back to you as soon as I hear back.

The purpose of this letter is to amend our previous Development Letter dated August 31, 2018. After attending the Animal Shelter Community Meeting on October 10, 2018 held at the Dante Club, additional concerns were raised that would impact Herndon Barstow Elementary School. We respectfully request mitigation measures related to the following:

- The likelihood that animals will be abandoned during the timeframe when the facility is closed would have a negative impact on the Herndon Barstow Elementary School. We have experienced that animals have a tendency to gravitate to active areas such as schools.
- Traffic is concentrated in the morning at the start of school and in the afternoon at the end of the school day, as a result traffic from the facility will have an impact on the school site. We request traffic mitigation measures be implemented to provide controlled intersections for children to cross and have a clear path of travel.
- As mentioned in our previous letter, we request noise mitigation as outlined in the environmental analysis.

With appropriate mitigation measures the District will continue to take a neutral position regarding the proposed development project. Developer impact fees from the proposed animal shelter and hospital will be classified under the commercial/industrial rate. The current Developer Fee Rates for commercial/industrial is \$.56 per square foot. Developer rates are evaluated annually and are subject to change. Please verify Developer Impact Fees prior to payment.

Kelly,

The folks from Fresno Humane Animal Services that will operate the proposed shelter have anticipated this issue even though it does not happen very often. The "Statement" below will be incorporated into the "Operational Statement" and will become part of the official Public Record. (if the project is approved for the site)

"The Proposed Animal Shelter will have clearly posted signage stating that it is illegal to abandon animals and that any violation will be reported to law enforcement. The shelter will be fully fenced and will be lit with shielded lighting. The entire facility will be equipped with monitored surveillance cameras which will be prominently mounted as a deterrent against animal abandonment or any criminal activity. In addition, the property will be posted with Animal Dispatch numbers in case of emergency. In the event of an abandonment of a dog or cat, the following procedures will be followed by shelter staff":

1. Staff will be electronically notified if the surveillance cameras detect any abandonment activity during the "off" hours.
2. Staff will travel to the site, collect the abandoned animal and administer standard intake procedures.
3. If necessary, staff will notify the emergency medical "partner" and Law Enforcement.

I am a homeowner in the "Herndon Acres" housing division - I am a "NO" for a rezone. I have lived out here for over 20 years and bought out here for being close to the city, but a quiet residential neighborhood. This IS a residential neighborhood and should be kept as one. We are a neighborhood and do not want a rezone to cause commercial business to come into our neighborhood.

In the meeting on October 10th at the Dante Club, Darrell Ridenour stated that his plan was to put a mini storage facility on the additional acreage not used for the shelter. You know, as well as I do, that people change their mind and once the area is rezoned, anything is then possible.

We already have more traffic issues then we would like to deal with. If you do not live out here, you truly don't understand the traffic problems of getting in and out of our neighborhood - it is terrible. I am a parent of Herndon Barstow elementary and a resident of the area of the proposed shelter. I am certain you have received plenty of emails from people in favor of the rezone of our neighborhood judging by the media attention they like to receive. However, I wonder if you actually consider putting yourself in our position as concerned parents and residents of the affected area. If I can briefly explain what this entire situation feels like to me, it goes as follows:

Imagine, a stranger to you and someone in desperate need of a home figures your home is exactly where he wants to live. Conditions are not favorable because you have children and especially because you can never be certain this person will not be a threat to you. There being shelters for homeless people available, this person fights through storms just to get into your home. For no apparent reason other than personal benefit. And his stay relies on your colleagues' vote to let him stay or make him move. There are people around you that respect you as an individual and know it is unfair for you, and there are others who solely consider this person needs a home.

Yes, as you have concluded, that person stands for the commercial area in question in our neighborhood. Does this not slightly scare you and help you think about how we really are going to be drastically affected by this rezone? We have enough footage to prove that Grantland Ave is a highly condensed street, which I have recorded myself to find out that every minute that passes by, 20 cars pass through. There have been accidents on this road and our children are in danger every day due to lack of infrastructure. I have never, ever, seen a school so affected and, on top of that, be burdened by the addition of even more traffic congestion before it is even considered that the school zone is not adequate enough to sustain itself, let alone a commercial lot.

I understand where people in favor of the shelter get their favoritism from; FHAS desperately needs a place for their own. But please, do not condition our school even more than it already is over a shelter that is able to be located in another area already conditioned. Tracy herself admitted that they were willing to work with them at the last meeting, until Brenda cut her off and didn't let her finish. Many of us caught this and are angered that there is still an argument over a rezone of our neighborhood.

If you read any of the Facebook comments, and I'm sorry if you have, you can see a constant "YES REZONE", that is becoming overwhelming to us because these people do not even live near us. This brings us back to the

We have to take care of the large animal's 7 days a week.

SECTION 820

"R-R" - RURAL RESIDENTIAL DISTRICT

The "R-R" District is intended to create or preserve rural or very large lot residential homesites where a limited range of agricultural activities may be conducted. The "R-R" District is intended to be applied to areas designated as Rural Residential by the General Plan. The minimum lot size that may be created within the "R-R" District without a special acreage designation shall be two (2) acres. The "R-R" District accompanied by the acreage designation of five (5) establishes that the minimum lot size that may be created within the District shall be five (5) acres.

(Added by Ord. 490.128 adopted 1-11-77; amended by Ord. 490.133 adopted 6-7-77)

SECTION 820.1 - USES PERMITTED

The following uses shall be permitted in the "R-R" District. All uses shall be subject to the property development standards in Section 820.5.

- A. One family dwelling units, not more than one (1) dwelling per lot.
- B. Accessory buildings including servant's quarters, accessory living quarters, garages and farm buildings.
- C. Agricultural crops, greenhouses, fruit trees, nut trees and vines.
- D. Bovine animals, horses, sheep, and goats where the lot area is thirty-six thousand (36,000) square feet or more and provided that the number thereof shall not exceed a number per each thirty-six thousand (36,000) square feet equal to four (4) adult animals in any combination of the foregoing animals and their immature offspring with not more than three (3) adult animals of a bovine or equine kind or combination thereof and their immature offspring or not more than six (6) immature bovine or equine animals or combination thereof where no adult animals are kept per each thirty-six thousand (36,000) square feet. Where the lot is less than thirty-six (36,000) square feet in area, but twenty thousand (20,000) square feet or greater in area, horses may be maintained for personal use in a number not to exceed two (2) animals with their offspring less than one (1) year of age.

(Amended by Ord. 490.191 adopted 12-3-79)
- E. Dogs and cats as domestic pets only (limited to three (3) or fewer animals four (4) months of age or older).

(Amended by Ord. 490.133 adopted 6-7-77)
- F. Home Occupations, Class I, in conjunction with a detached single family residential unit, subject to the provisions of Section 855-N.

(Amended by Ord. T-027-288 adopted 2-25-86)

G. Mobilehome occupancy, not more than one (1) mobilehome per lot, subject to the provisions of Section 856.

H. Signs subject to the provisions of Section 820.5-K.

I. Storage of petroleum products for use by the occupants of the premises, but not for resale or distribution.

J. Storage or parking of boats, trailers, recreational vehicles, or commercial vehicles, limited to the private non-commercial use by the occupants of the premises.

K. The keeping of rabbits and other similar small furbearing animals for domestic use on a lot containing not less than thirty-six thousand (36,000) square feet.

(Amended by Ord. T-038-306 adopted 5-22-90)

L. The maintaining, breeding, and raising of poultry for domestic use not to exceed five hundred (500) birds and the maintaining, breeding, and raising of poultry for FFA, 4-H and similar organizations. In no case shall the poultry facility be kept or maintained on a lot containing less than thirty-six thousand (36,000) square feet.
