IN THE MATTER OF DECREASING THE FRESNO )  
WESTSIDE MOSQUITO ABATEMENT DISTRICT BOARD) RESOLUTION  
OF TRUSTEES FROM SEVEN TO FIVE MEMBERS )

WHEREAS, the Fresno Westside Mosquito Abatement District was formed in 1959 to provide mosquito surveillance and control services in Fresno County governed by a seven-member Board of Trustees; and

WHEREAS, on March 14, 2024, the Fresno Westside Mosquito Abatement District Board of Trustees approved Resolution No. 301 requesting of the Board of Supervisors a decrease of the members of the Board of Trustees from seven to five members.

WHEREAS, Health and Safety Code section 2025(b) states a board of trustees may adopt a resolution requesting the Board of Supervisors of any county that contains territory within the district to increase or decrease the number of members of the board of trustees who represent the unincorporated territory of that county within the district. The resolution shall specify the number of members and the areas of the unincorporated territory for which the board of trustees requests the increase or decrease.

WHEREAS, Health and Safety Code section 2025(c) states within 60 days of receiving a resolution adopted pursuant to subdivision (b), the Board of Supervisors shall order the increase or decrease in the number of members of the board of trustees, consistent with the board of trustees' resolution.

WHEREAS, Health and Safety Code section 2025(c) states if the Board of Supervisors orders a decrease in the number of members of the board of trustees, the Board of Supervisors shall designate the trustee or trustees whose office shall be eliminated at the termination of the trustee's current term of

1 office. Any trustee whose office is designated to be eliminated shall continue to serve until his or her  
2 term of office expires.

3 NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors hereby  
4 orders decreasing the Fresno Westside Mosquito Abatement District Board of Trustees from seven to  
5 five members by eliminating the two vacant County at Large positions effective June 18, 2024.


