PROCLAMATION OF CONTINUED EXISTENCE OF A LOCAL EMERGENCY BY THE BOARD OF SUPERVISORS COUNTY OF FRESNO, STATE OF CALIFORNIA

IN THE MATTER OF PROCLAIMING THE CONTINUED EXISTENCE OF A LOCAL EMERGENCY

RESOLUTION

WHEREAS, the California Emergency Services Act (Government Code section 8630, *et seq.*) establishes procedures for proclaiming emergencies and for responding promptly to the needs that arise during emergencies; and

WHEREAS, under section 2.44.050 of the Fresno County Ordinance Code, the County Administrative Officer is authorized as the Director of Emergency Services of the County; and

WHEREAS, section 2.44.060 of the Fresno County Ordinance Code and section 8630 of the Government Code empower the County Administrative Officer acting as the Director of Emergency Services of the County to proclaim the existence of a local emergency when the County is affected by or likely to be affected by a public calamity if the Board of Supervisors (Board) is not in session; and

WHEREAS, the Director of Emergency Services of the County does hereby find and declare that a disaster, which severely impairs public security of an important food product, continues to be created by conditions of extreme peril to the processing and fresh tomato crop within Fresno County, due to the Beet Leafhopper (BLH), the vector of Beet Curly Top Virus (BCTV), a disease known to cause serious damage to tomato crops. California is the largest producer of processing tomatoes and the second largest producer of fresh tomatoes in the U.S. Processing tomato production is also concentrated in Fresno County. Fresno County is also a significant producer of fresh tomatoes; and

WHEREAS, BCTV stunts young plants and can result in complete loss in heavily infected fields. About 50% of the total fresh market and processing tomato acreage in the San Joaquin Valley is at risk of infection in years when insect and virus pressure are high; and

WHEREAS, processing tomatoes are grown annually in California on approximately 235,000 acres, including 67,750 acres in Fresno County in 2023, representing a production value of \$503,937,000; and

WHEREAS, tomato growers heavily rely on neonicotinoids to combat the BLH and the BCTV, as no effective alternatives exist. Without effective control of the BLH, damage to affected tomato crops in Fresno County could be as high as 70% to 90%; and

WHEREAS, the use of neonicotinoids on certain crops is restricted under Title 3 of the California Code of Regulations sections 6990 through 6990.16, effective January 1, 2024, however, an exemption in section 6990(c)(2) allows their application during a local emergency declared under Government Code section 8630. Under this exemption, commercial tomato growers must obtain written recommendations from a licensed pest control advisor and retain records of the application for at least two (2) years; and

WHEREAS, the Fresno County Director of Emergency Services proclaimed a local emergency on April 2, 2025; and

WHEREAS, on April 8, 2025, the Board of Supervisors of the County of Fresno ratified the proclamation by the Director of Emergency Services and adopted a resolution proclaiming the local emergency status; and

WHEREAS, large and alarming numbers of the BLH continue to be found in tomato farms in Fresno County; and

WHEREAS, the BCTV has been detected in tomato plants in Fresno County; and WHEREAS, the full scope of damage of the BLH in Fresno County cannot reasonably be determined at this time but can be mitigated in part if immediate action continues to be taken on an emergency basis, as stated below; and

WHEREAS, the Fresno County Director of Emergency Services, after consulting with the Fresno County Agricultural Commissioner, has determined that the BLH is still present in Fresno County and continues to present a danger to all tomato crops in the County; and

 NOW THEREFORE, IT IS HEREBY PROCLAIMED by the Board that a local emergency

 continues to exist throughout Fresno County and that the local emergency shall continue to be

1	in effect for sixty (60) days pursuant to Government Code section 8630, after which the need for
2	the local emergency shall be reviewed by the Director of Emergency Services, and the Board, to
3	determine whether to continue the local emergency or to terminate it; and
4	IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of said local
5	emergency, the powers, functions, and duties of the emergency organization of this County
6	shall be those prescribed by state law, ordinances and resolutions of this County, and by the
7	Fresno County Operational Area Master Emergency Services Plan, as approved by the Board
8	and under this resolution; and
9	IT IS FURTHER ORDERED the Director of Emergency Services shall take appropriate
10	steps to continue to notify the State office of Emergency Services of this Proclamation and of
11	the steps taken hereunder to address this local emergency; and
