WHEREAS, the County of Fresno, Sheriff-Coroner's Organization 3111 will receive \$108,000 as an Operating Transfer In from the Sheriff-Coroner Special Revenue Fund 0095, Debtor Assessment Fee Subclass 17653, Debtor Assessment Fee Org 1454; and

WHEREAS, the County of Fresno, Sheriff-Coroner's Organization 3111 will receive \$44,000 as an Operating Transfer in from the Sheriff-Coroner Special Revenue Fund 0095, Sheriff Automated GC 26731 Subclass 17654, Sheriff Automated GC Org 1455; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Sheriff-Coroner's Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Sheriff-Coroner's Org 3111 as follows:
