WHEREAS, the District Attorney received \$354,435 from AB118 funding in SRF 0271, Org 2866 for Post Release Community Supervision (PRCS) revocation hearings in the FY2020-21; and

WHEREAS, \$354,435 is not included in the adopted appropriations and estimated revenues of the District Attorney Org 2860 for the FY 2020-21; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2020-21 appropriations of the District Attorney Org 2860 as follows:




