NOW, THEREFORE, IT IS ORDERED that the Fresno County Sheriff's, or her/his designee's, prior submittal of an application to and acceptance of an award from the California Department of Parks and Recreation, Division of Boating and Waterways for the Boating Safety and Enforcement Financial Aid Program for FY 2023-24 in the funding amount of \$452,764 is hereby ratified, approved and authorized.

BE IT FURTHER RESOLVED, that the Chairman of the Board of Supervisors is hereby authorized and directed on behalf of the County of Fresno to execute the Boating Safety and Enforcement Financial Aid Program Agreement with the California Department of Parks and Recreation Division of Boating and Waterways for FY 2023-24 in the amount \$452,764.

BE IT FURTHER RESOLVED, that the Fresno County Sheriff, or her/his designee, is hereby authorized and directed on behalf of the County of Fresno to execute claims for
