ORDINANCE NUMBER 26-010

AN ORDINANCE AMENDING SECTION 4300 – INFORMATION TECHNOLOGY SERVICES OF THE MASTER SCHEDULE OF FEES, CHARGES, AND RECOVERED COSTS FOR THE COUNTY OF FRESNO, BY ADDING SUBSECTIONS 4301, 4303, 4306, 4318, 4319 AND 4340-4343; DELETING SUBSECTIONS 4309, 4313-4315 AND 4330; AND AMENDING SUBSECTIONS 4302, 4304, 4305, 4308, 4317, 4320, 4321, 4323, AND 4326-4329 TO REVISE VARIOUS FEES.

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1. The Master Schedule of Fees, Charges and Recovered Costs for the County of Fresno, Section 4300 – Information Technology Services, is hereby amended, by adding subsections 4301, 4303, 4306, 4318, 4319, and 4340-4343; deleting subsections 4309, 4313-4315, and 4330; and amending subsections 4302, 4304, 4305, 4308, 4317, 4320, 4321, 4323, and 4326-4329, relating to the recovery of costs for Information Technology Services of the Information Technology Services Department (ITSD) to public agencies, as set forth in Exhibit A, attached hereto and incorporated herein by reference.

Section 2. This ordinance shall take effect thirty (30) days from the date of its final passage.

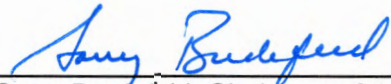
