## **Narrative**

Source: On 06/03/2015, at about 1100 hours members of Fresno County Sheriff's NET Team contacted the resident at 34222 High Mountain Lane, Tollhouse, Ca. regarding outdoor marijuana growing on the property.

Victim statements: NONE.

Witness statements: NONE.

Investigation: Upon our arrival team members were wearing identifiable SHERIFF uniforms. We exited our marked and unmarked patrol vehicles at the location listed and contacted Donald Christopher Kolz who identified himself as the property owner. I advised Donald that we were there regarding the marijuana growing on the property. Donald was cooperative and allowed members of the team to access his residence and the marijuana grow that was located at the rear of the property. I read Donald the Miranda Warning per my department issued SO-71 card. Donald stated he understood his rights and began answering my questions. Donald advised that he grows marijuana at the location and has done so since 2008 when he purchased the property. Inside the residence there were several boxes of butane and PVC pipe used in making butane honey oil. Donald stated he makes hash out of the marijuana.

A total of 40 plants were found on the property.

Donald was advised of the Fresno County Ordinance which states there shall be no marijuana plants grown outdoors in the county of Fresno. Donald was given an ordinance citation for the plants found growing on the property. Copies of the citations will be forwarded to the county board of supervisors.


