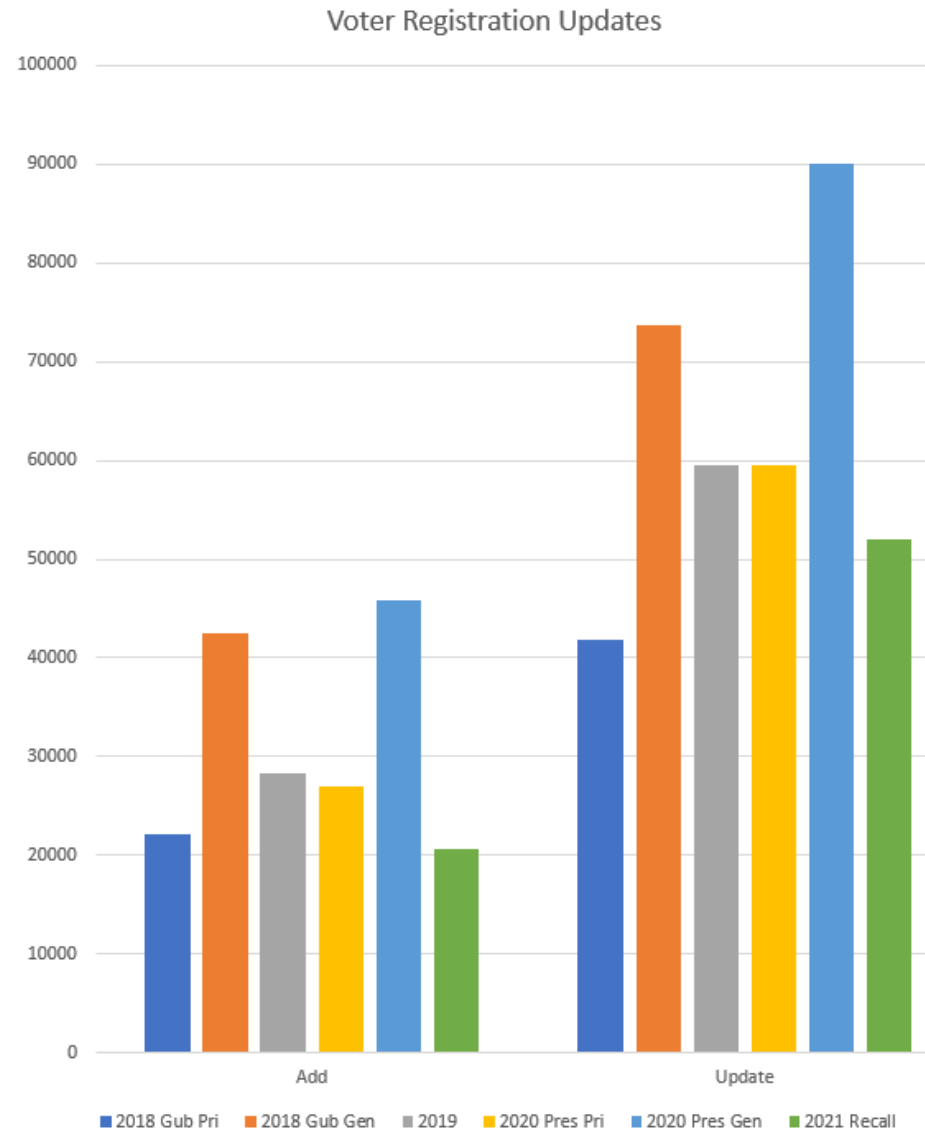

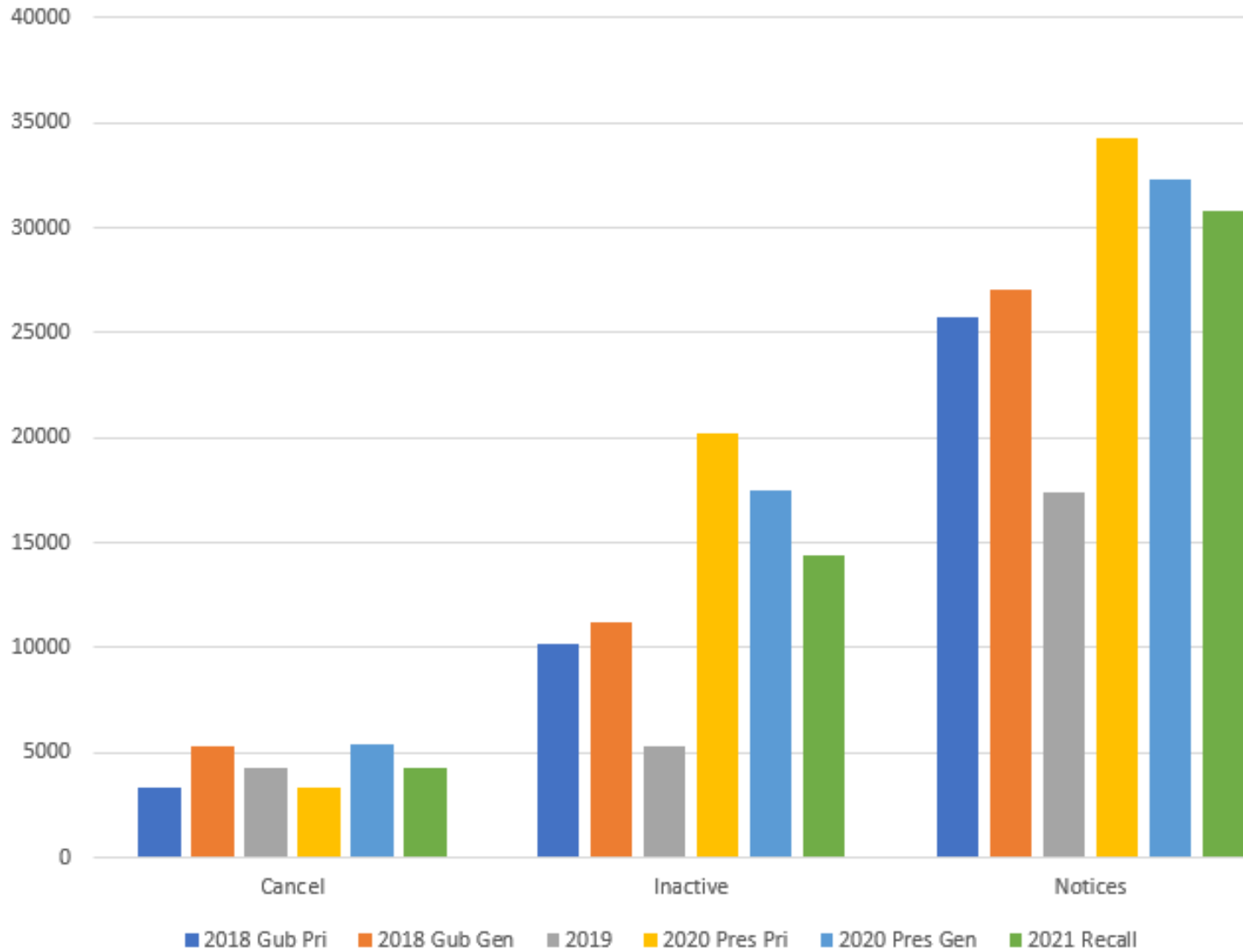

 - ▶ December 2022

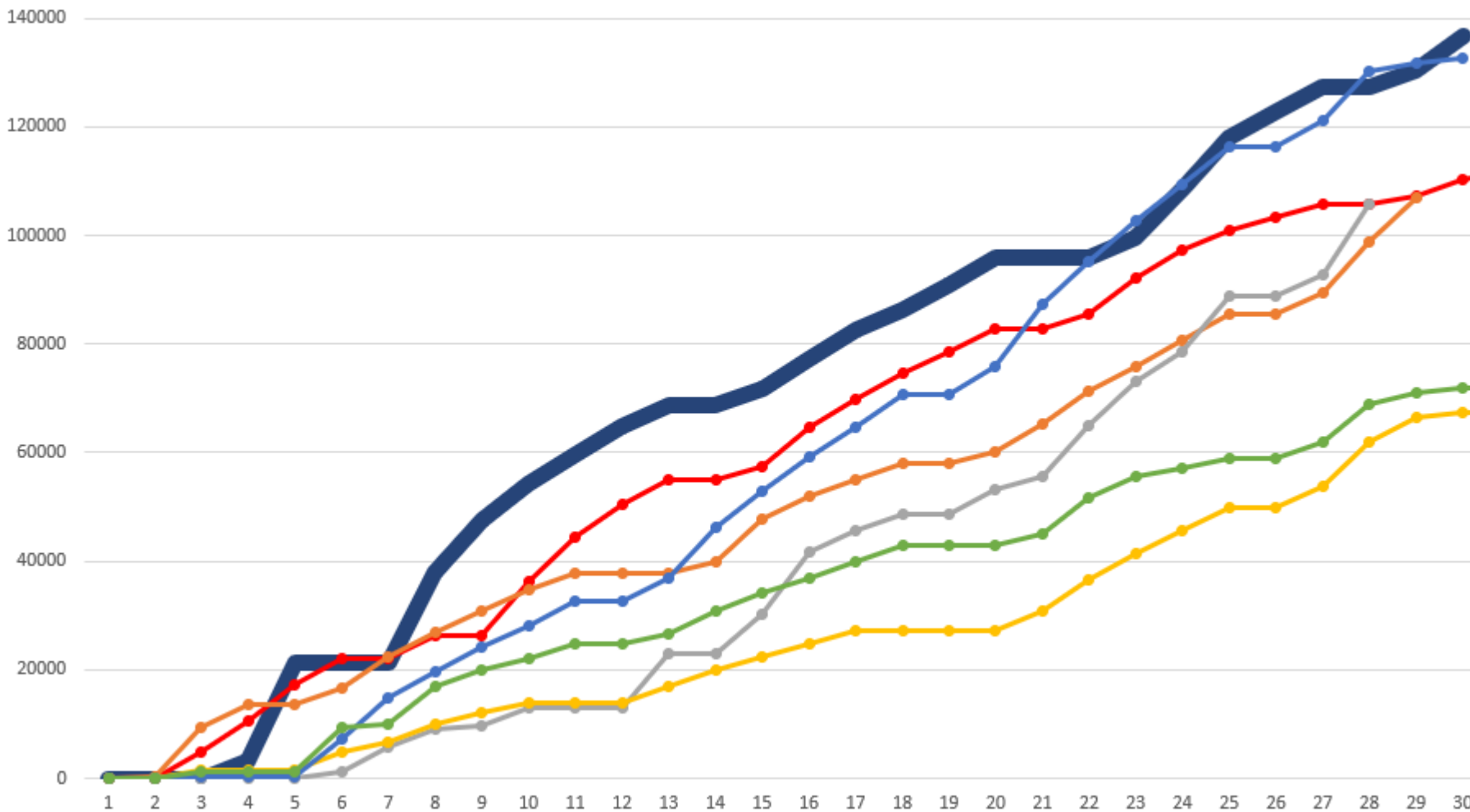
Public Input and Educational Meetings

- ▶ Educational Presentation followed by public comment period
 - ▶ How Voter Registration Works/Registration Maintenance Process
 - ▶ Fresno County's Voting System
 - ▶ Election Security Procedures
- ▶ Six presentations held in June and July.
 - ▶ Online/Telephone options available for last two meetings.
 - ▶ Attendance varied between 2 and 30
 - ▶ Questions heavily focused on recounts, audits, and what California law allows

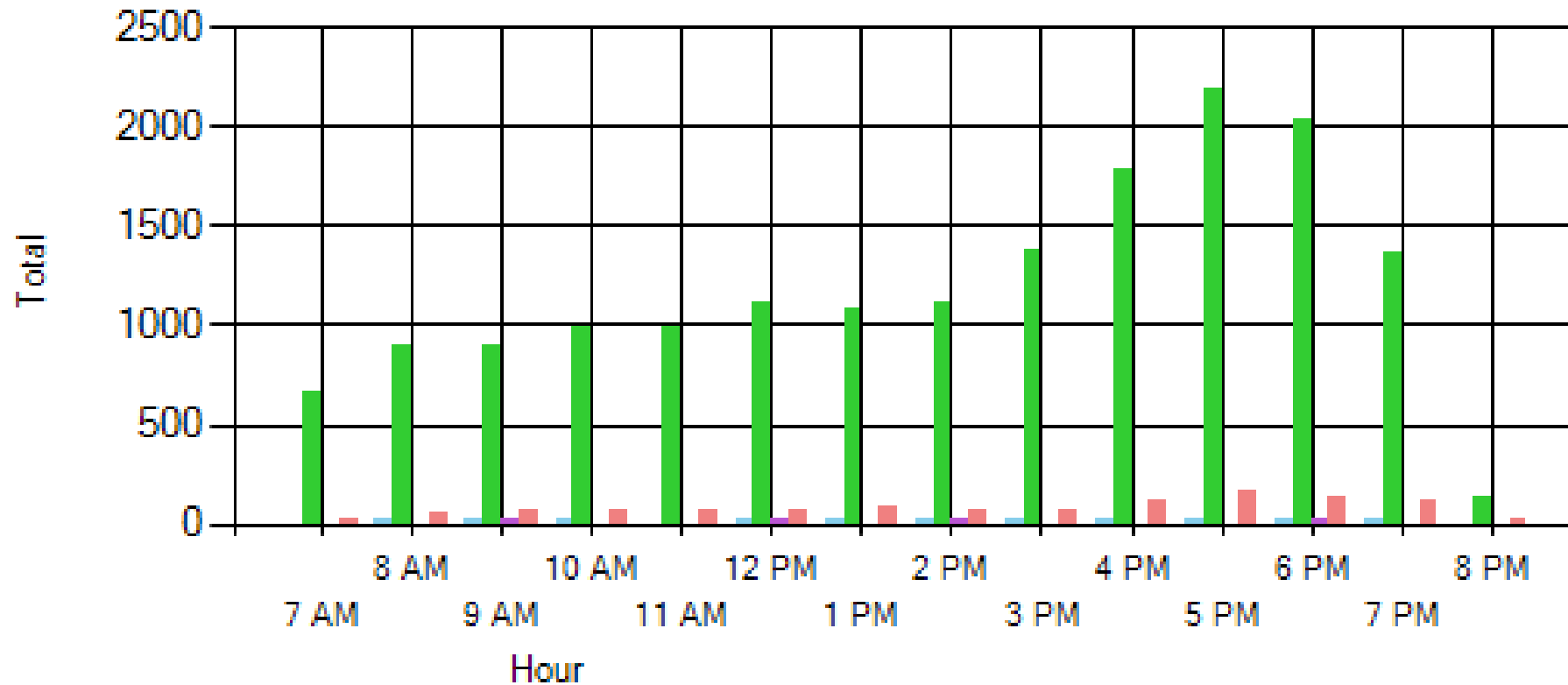
Sept 14, 2021, California Gubernatorial Recall Election

- ▶ 506,684 Registered Voters
- ▶ 260,685 Votes Cast - 51.45% Turnout
- ▶ ~25,000 Votes Cast at Vote Centers - 9.5% in-person voting
- ▶ ~60,000 Voter interactions on Election Day

- ▶ Fresno County Library
- ▶ Department of Behavior Health
- ▶ Internal Service Department - Support Teams and Management
- ▶ Election Day Volunteers from HR and Public Works
- ▶ 50 volunteers and their families Election Night

Sept 14, 2021, California Gubernatorial Recall Election - Next Steps

- ▶ Local certification this week - Secretary of State must certify the statewide results by October 22
- ▶ Recount - CA Elections Code 15621
- ▶ Requestor is responsible for the cost of the recount unless a change in results is found
- ▶ Current estimate for Fresno County - \$120,000 to \$140,000
