SECTION 600 - PAID ANNUAL AND BEREAVEMENT LEAVES

- 611.4 Annual Leave IV (formerly known as Modified Annual Leave II; also known as Annual Leave 04 and Annual Leave 2004) - applies to employees in Representation Units 2, 11, ~~13~~, 19, 30, 31, 37, 42, and 43, pursuant to their respective MOU who were hired on or after October 10, 1983; leave accrual is capped at six hundred (600) hours.
- 611.5 Annual Leave VI - applies to all employees in Representation Units 3, 4, 7, 10, 12, ~~13~~, 22, 25, 36, and 39 (pursuant to MOU) hired on or after October 10, 1983; leave accrual is capped at six hundred and fifty (650) hours. This section shall also apply to employees designated under UNR, MGT, SMG, SMS, ADH and HDS, effective April 27, 2026.
