RESOLUTION NO. 18-052

WHEREAS, Fresno State Bulldog Football became the second team in Football Bowl Subdivision (FBS) history to go from a double-digit loss season (1-11 in 2016) to a double-digit win season (10-4 in 2017). With its bowl victory against Houston, in the Hawaii Bowl, Fresno State finished with an eight-game turnaround this season for the second-best effort in FBS history.

WHEREAS, Fresno State Bulldog Football was one of only 26 schools to finish 2017 with double-digit wins (10). Of those 26, four were in the pacific time zone: Fresno State, San Diego State, USC and Washington. The Bulldogs were one of six teams in the FBS to have played five or more opponents that owned double-digit wins records. Of those six teams to have played at least five double-digit win opponents, Fresno State, Ohio State and Auburn were the only three to own a double-digit win seasons themselves at the same time.

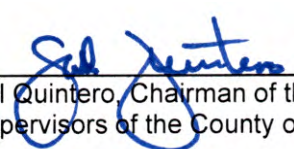
WHEREAS, Fresno State Bulldog Football completed the 2017 season with a 10-4 overall record for a .714 overall winning percentage. This record included a 7-1 Mountain West Conference record for a .875 conference winning percentage, with a 5-1 home record and a 5-3 road record. The Bulldog Offense averaged 27.14 points per game while its Defense held opponents to 17.93 points per game.

WHEREAS, On Jan. 8, 2018, the Associated Press and the Amway National Coaches Polls both had Fresno State receiving votes in its respective end-of-year polls. The Bulldogs ranked 30th in the nation in the Amway National Coaches Poll and 32nd in the nation in the Associated Press Top 25 Poll.

NOW THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors hereby proclaims February 6, 2018 as Fresno State Football Day in the County of Fresno. GO BULLDOGS!
