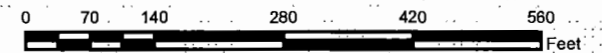

EXISTING ZONING MAP

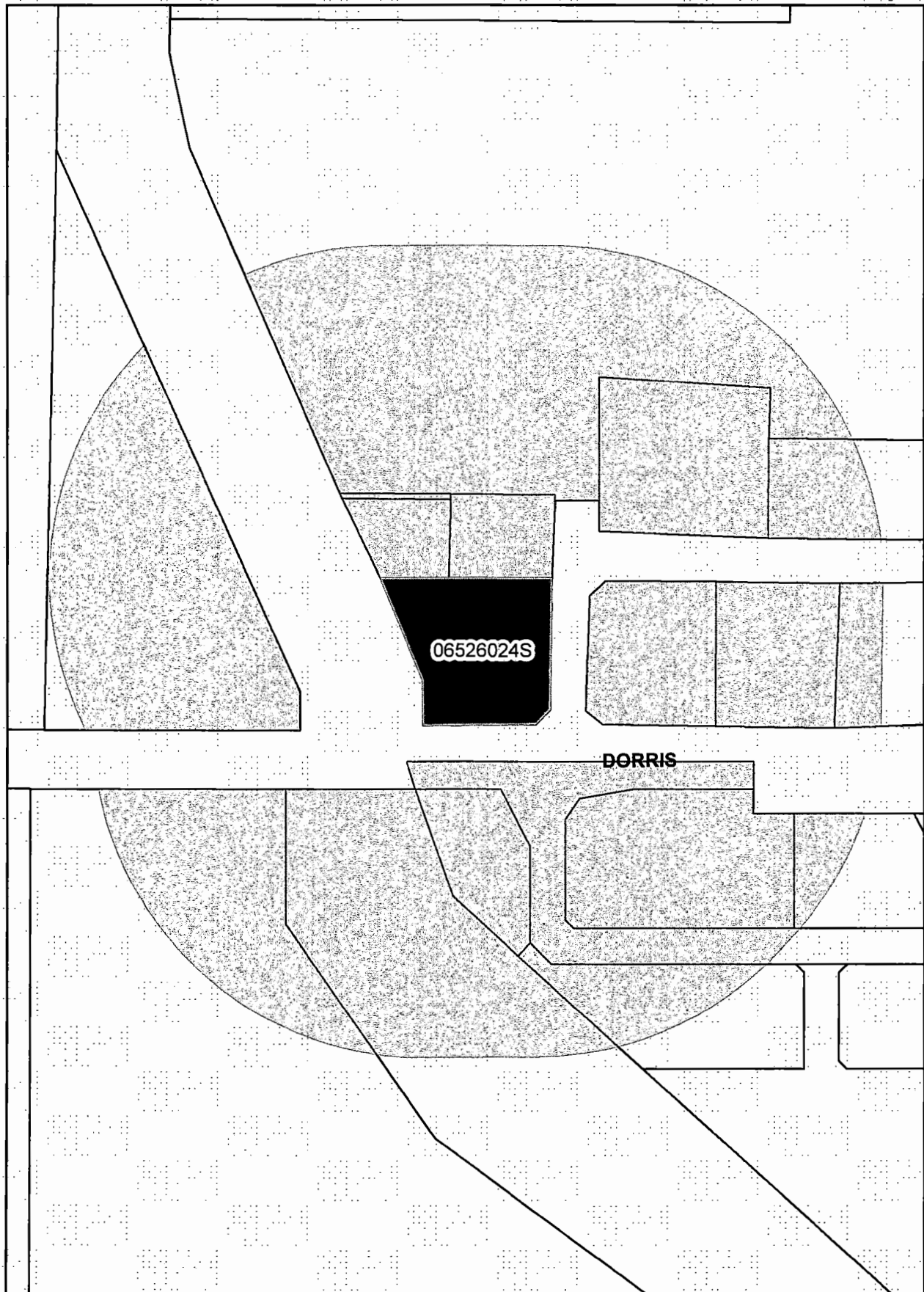
