Re: Past Ten Years- FBOS

JUST THE FACTS!!

REASON:

For the past ten years many of our citizens with homeless family members have watched FBOS not follow the proposed budgets. Our tax dollars pay for FBOS professional accountants to make precise distribution evaluations. This allows for proper funding to each category of need within our county.

Bottom-line our county Board has not followed the process to a T. They made outside decisions to fund their "buddy" system first. For this reason I request exact accounting as to their decided distributions for each of the Ten years in question. Where's the Transparency ??

Ultimately this will reflect exact dollars designated for Homeless Funds which were not used as directed by the accountants skillful estimates. All the Counties which are high violators, i.e. monetary distribution revealing excessive movement of Homeless funds to other county needs with lower priority should be highlighted. Naturally the numbers never lie!

PLAN:

Put the list with the ten highest fund movers, with an alternate list of actual money receivers. For Example:

Salinas BOS had 1,250,000 designated for the homeless, yet only received 250,000; this is a shortage of one million. Second list shows who received the Million and when. Then compare to how many homeless passed away due to not getting care because of the shortfall.

EPOC PERSONNEL:

They came up to my car unannounced while I was on the phone calling FPD, see report ending 0759, filed two days August 8-13-24 & 8-14-24. Now they are lashing out at me due to the fact I've been driving my son to the doctors! Other residents with special needs are complaining they can not contact their parents. (Maxwell office Advised, 8/14/24.)

They scramble the WiFi! They ask to use the phone or please call the doctor. RH folks dance around until it's too late for folks to get a ride or confuse paperwork! I witnessed this myself. The fella was polite and did ask for the ride in accordance with RH rules!

So what is really going on? Another money grab system?

BE INFORMED Look this info up I did this! This is what HURTS others!

{You know when someone continually skirts the truth this is called, "pseudologia fantastica" or "mythomania", which causes the receiver of the message great stress, i.e. List of known stressors:

- **Life events: The death of a loved one, divorce, job loss, illness, injury, marriage, retirement, or moving to a new home**
- **Financial issues: Increased financial obligations or money troubles**
- **Relationship conflicts: Marital separation, reconciliation, or emotional problems like depression, anxiety, anger, grief, or guilt**
- **Social factors: Poor access to services like medical care, green spaces, or transportation, or living through a stressful community-wide, national, or global event**
- **Traumatic events: Exposure to natural disasters, accidents, or violent acts**
- **Smaller stressors: Long daily commutes, rushed mornings, or stigma and discrimination**

Then authorities want to know why folks are stressed and/or have so much emotional upheaval in Fresno County. All citizens should say the truth from the get go in order not to waste time, money or mostly cause continued creation of un-needed. stress.

As the receiver of a message in business I would expect all of us to be somewhat considerate and honest. I know I'm imperfect too! I make mistakes and get upset, especially when information given does not sound solid! }

GET SOME ORGANIZED PROFESSIONALS without a hidden agenda! Using Medi-cal Dollars to fund the operation? This is against the law too!

These folks are wasting my tax dollars, creating more trauma for my son. Derrick simply wants a schedule/list as to each of the Support days in date order. He also wants them to be mindful of his hearing loss in the process of going deaf. Derrick states he has been asking to be checked by the hearing doctor, since he entered CAP, to upgrade the aids lost upon contact with law enforcement in Clovis.

Just so you understand this process, according to doctors it's better for him to try to manage the loss through use of the aids! Derrick wants to know, has a right to ask for Staff's name and time they will go to each appointment! For some reason people you have selected are driving EPOC folks onto the streets. Is this the plan? This is abuse of one group of people... against our civil rights!

They are abusing a special person needing/asking for care, concern and mostly someone to listen and support him getting hearing aids, learning sign language, job placement, housing and a support dog! It took me filing a hate crime report for County S. Holt to assist! (See case #ROH2023-1102-428.) This should not be!
