WHEREAS, funds in the amount of \$158,655.29 will be transferred from the FY 2015-16 Sheriff-Coroner’s budget to the FY 2016-17 Sheriff-Coroner’s budget to complete the purchase of the seven vehicles; and

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector eliminate the appropriations and any related encumbrances as follows:
