RESOLUTION

WHEREAS, the Department of Social Services requires \$400,000 to purchase two vans for Outreach services in rural and disaster areas; and

WHEREAS, the Department of Social Services Org 5610 will receive \$400,000 as an Operating Transfer In from the Welfare Advance Fund Org 1120 (\$344,599), the 1991 Realign-Social Services Org 5246 (\$16,026), and the Protective Services Subaccount Org 6210 (\$37,067); and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the Department of Social Services Org 5610 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Department of Social Services Org 5610 as follows:
