IN THE AMOUNT OF \$315,000)

WHEREAS, the County of Fresno, County Buildings Org. 0131, requires an increase in appropriations in the amount of \$315,000 for the purchase of property located at 815 G Street, Reedley, CA 93654 (APN 368-010-06T) to allow the County’s Agriculture Department to continue its occupancy in the building in the current year; and

WHEREAS, said costs will be financed by revenue from the Interest & Miscellaneous Expense, Org.2540 in the amount of \$315,000; and

WHEREAS, Interest & Miscellaneous Expense, Org.2540 has funds available the for the purchase of property located at 815 G Street, Reedley, CA 93654 (APN 368-010-06T) in the amount of \$315,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2023-24 County Buildings, Org. 0131 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 County Buildings, Org. 0131 as follows:


