SECTION 100 - FOOTNOTES

- L. Employees in the Deputy Public Administrator II and Deputy Public Administrator/Guardian II classifications who are assigned by management to perform lead work involving assigning, reviewing and coordinating the work of employees shall receive an allowance of fifty dollars and no/100 (\$50.00) per pay period, pro-rated for the actual number of hours worked, not to exceed eighty (80) hours per pay period. There shall be no allowance paid during periods of annual leave, sick leave use, and during holiday time off.

Persons designated by the department head to receive this allowance do so at the pleasure of the department head and assignment decisions designating or removing designation are not grievable or appealable to the Civil Service Commission, or subject to challenge in a court of law.
