

1 **AMENDMENT NO. 2 TO SERVICE AGREEMENT**

2 This Amendment No. 2 to Service Agreement (“Amendment No. 2) is dated  
3 \_\_\_\_\_ and is between each individual Contractor listed in Exhibit A-I “List of  
4 Contractors” attached hereto and incorporated herein by reference, and collectively hereinafter  
5 referred to as “Contractor”, and the County of Fresno, a political subdivision of the State of  
6 California (“County”).

7 **Recitals**

8 A. On June 24, 2025, the County and the Contractor entered into Agreement No. 25-321  
9 (“Agreement”), for outpatient specialty mental health services for persons eligible for Medi-Cal.  
10 On July 8, 2025, the County and the Contractor executed Amendment No. 1 (Agreement No.  
11 25-350), to add 18 more Contractors to the existing master agreement.

12 B. The County and Contractor now desire to further amend the Agreement to expand its  
13 network of individual and group providers to ensure the ability to serve County of Fresno  
14 persons served and to meet California Department of Health Care Services network adequacy  
15 standards.

16 C. The County now desires to amend the Agreement to add the following contractors: (1)  
17 Khalsa Foundation, (2) Reflection Family Therapy, (3) The Way Forward Professional Clinical  
18 Counselor Corporation, (4) Nasim Nancy Lynch, and (5) Quality Group Homes, Inc.

19 The parties therefore agree as follows:

20 1. All references to Revised Exhibit A shall be deemed references to “Exhibit A-I”. Exhibit  
21 A-I is attached and incorporated by this reference.

22 2. The parties agree that upon execution of this Amendment No. 2, the Agreement is  
23 further revised, updated, and amended to add Khalsa Foundation, Reflection Family Therapy,  
24 The Way Forward Professional Clinical Counselor Corporation, Nasim Nancy Lynch, and  
25 Quality Group Homes, Inc.

26 3. When both parties have signed this Amendment No. 2, the Agreement, Amendment No.  
27 1 and this Amendment No. 2 together constitute the Agreement.

28 4. The Contractor represents and warrants to the County that:

1 a. The Contractor is duly authorized and empowered to sign and perform its obligations  
2 under this Amendment.

3 b. The individual signing this Amendment on behalf of the Contractor is duly authorized  
4 to do so and his or her signature on this Amendment legally binds the Contractor to  
5 the terms of this Amendment.

6 5. The parties agree that this Amendment may be executed by electronic signature as  
7 provided in this section.

8 a. An "electronic signature" means any symbol or process intended by an individual  
9 signing this Amendment to represent their signature, including but not limited to (1) a  
10 digital signature; (2) a faxed version of an original handwritten signature; or (3) an  
11 electronically scanned and transmitted (for example by PDF document) version of an  
12 original handwritten signature.

13 b. Each electronic signature affixed or attached to this Amendment (1) is deemed  
14 equivalent to a valid original handwritten signature of the person signing this  
15 Amendment for all purposes, including but not limited to evidentiary proof in any  
16 administrative or judicial proceeding, and (2) has the same force and effect as the  
17 valid original handwritten signature of that person.

18 c. The provisions of this section satisfy the requirements of Civil Code section 1633.5,  
19 subdivision (b), in the Uniform Electronic Transaction Act (Civil Code, Division 3, Part  
20 2, Title 2.5, beginning with section 1633.1).

21 d. Each party using a digital signature represents that it has undertaken and satisfied  
22 the requirements of Government Code section 16.5, subdivision (a), paragraphs (1)  
23 through (5), and agrees that each other party may rely upon that representation.

24 e. This Amendment is not conditioned upon the parties conducting the transactions  
25 under it by electronic means and either party may sign this Amendment with an  
26 original handwritten signature.

27 6. This Amendment may be signed in counterparts, each of which is an original, and all of  
28 which together constitute this Amendment.

1 7. The Agreement as previously amended and as amended by this Amendment No. 2 is  
2 ratified and continued. All provisions of the Agreement as previously amended and not  
3 amended by this Amendment No. 2 remain in full force and effect.


