WHEREAS, the Department of Public Health Organization 5620 requires \$412,675 to meet expenditures associated with the purchase of Power Generators and its related costs; and

WHEREAS, the Department of Public Health Organization 5620 will receive \$412,675 as an Operating Transfer In from Special Revenue Fund 0080, Subclass 17366, Miscellaneous Public Health Fund Organization 1166; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues of the Department of Public Health Organization 5620; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Department of Public Health Organization 5620 as follows:




