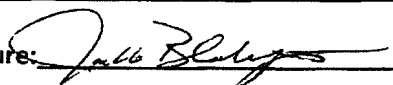

Kim & I are donating the land and the funds to build this shelter so that our community can have an attractive adoption center in addition to a beautiful animal shelter. The shelter is designed to be community friendly and welcoming. Both Kim and I helped design the proposed shelter in order for it to be an attractive destination where families will enjoy their visit and adopt a pet that needs a good, loving home.

Mr Pacheco,

My name is Katie Lewis and I am a voting Fresno County resident.

I attended the board of supervisors meeting last week on September 11th, in support of the motion to pass rezoning of the property owned by Derrell Ridenour, off of Herndon and 99, for the use of a new shelter location for Fresno Humane Animal Services. Unfortunately, Fresno is known throughout the country as having one of THE highest euthanasia rates in the nation, which is due largely in part to antiquated animal control measures. At the meeting, I heard a lot of "Fresno Humane is only about the animals". While this was stated by supporters in a positive manner, I know that good animal control is not simply about the animals, but about improving the community lives of residents as well, which Fresno Humane also strives for. This is not simply an issue that has an impact on the animals of Fresno County, but an issue that affects the safety and well-being of Fresno County residents. Having lived in Fresno County my entire life, it is so apparent the need for higher standards of animal control. Loose animals are a huge safety concern and an issue that is not an apparent concern to a lot of county residents. Living in a more rural area, residents around my neck of the woods don't understand the importance of leash laws, vaccines, spay and neuter, and general animal laws and safety issues. There has never been a shelter group more willing to work on educating the general public, providing assistance to those in need, and improving the safety and well-being of area residency. I have utilized Fresno Humane's services on many occasions, from having them come pick up loose animals, to utilizing their low cost spay and neuter services. I have a neighbor that didn't understand the dangers of letting his dogs free roam and Fresno Humane was able to educate this man on ways to keep his dog in, without them having to confiscate the animals. So many other agencies wouldn't create the time for

educational services like this and would either ignore the issue, or simply use a quick fix for the issue, which could

Include euthanasia. Fresno Humane makes a huge difference in my community by improving the safety of my neighbors and myself, as well as increasing awareness for higher standards of animal welfare. They do so much with so little and unfortunately don't have the capacity to do even more that is desperately needed to help not only animals, but residents.

I know it was suggested, at the meeting, that Fresno County should use the budget they currently have for a shelter, as well as one of the many properties owned already by the county, to erect a shelter without the help of Mr Ridenour. Unfortunately, we all know the county budget will lead to an very insufficient shelter for the county's animal control needs. There would be a shelter but it would be built to the bare minimum standards and would continue the current idea that shelters are to be out of sight, out of mind and animal control is reactive, not proactive. Many Fresno city residents I know, aren't even aware of the location of the city shelter, CCSPCA, because again, it is out of sight, not in an easily accessible or highly trafficked area. The property for this proposed county shelter is such a gift to the county that would put Fresno County in line with other high functioning shelters all over the US. Fresno has one of the worst reputations in all the nation for animal welfare. It is an issue that can never be mended by our antiquated animal control ways, that have been in practice for decades. It will take the new, innovative measures that Fresno Humane is already enacting on a small scale, and that they hope to be able to implement on a larger scale with a new, high functioning animal shelter. The only way we can change the community's views on responsible animal ownership is to lead by example and provide accessible resources to the community, which Fresno Humane is ready to do. The location of the proposed shelter is so so important in being a leading example to the community. It is vital that it be a destination that is inviting to all people. Easy accessibility in a warm, inviting neighborhood is key to encourage people to be a part of this needed change. So many people view shelters as old stinky buildings, located in the middle of nowhere, that no one would want to visit unless they had to. Many people i know talk about how they could never visit our city shelter or volunteer there because it is just too depressing. I love that so many counties around the nation have decided to adopt a more inviting environment to encourage community involvement. I

sincerely hope Fresno will hop on this bandwagon as well. Mr. Ridenour has given Fresno County such a generous gift. I can't even begin to understand why we would want to turn his gift down, or insult him by trying to renegotiate his gift. This is a once in a life time opportunity for Fresno County.

With that said, I urge you to vote yes on the approval of the rezoning of the land donated to Fresno Humane Animal Services, for the use of a new animal shelter. Thank you for your time.

Dear Supervisor Brian Pacheco:

My name is Elisa Trinaystich and I live in the La Ventana Sub division a little under a mile from the proposed site, and as I had mentioned in my address to the Board of Supervisors on September 11, 2018, I support the proposed re-zoning. Unfortunately, this time I will not be able to address the Board of Supervisors in person as I did for the previous Board of Supervisor Meetings regarding Fresno Humane. I was very disappointed not only in the “neighbors” in this area, but in the Board of Supervisors, as I feel like they were taken advantage of and did not make any good faith efforts to dig any further prior to the meeting or to postpone the meeting until everything could be addressed and a decision could be made.

More people knew about the meeting and proposed rezoning than they originally lead on. One person in particular, knew about the meeting and publically posted about this on the Next-Door App. I cannot verify how many people saw this post for sure, but can verify that two people “Thanked” her for her post. In the Board of Supervisors video, this same neighbor began her speech at 2 hours and 1 minute, 0 seconds, and tells the board she did not know about the Community Meeting that occurred on May 23, 2018 at Dante Club. Please see the picture below, where she contradicted herself in her own post. (see section A on next page).

In addition, during the time leading up to the meeting on September 11, 2018, I, along with other neighbors, had asked that the most vocal people reach out to learn what I had learned from the meeting. One neighbor specifically responded with the picture below, to which this neighbor said he did not need to speak with Derrel (see section B on next page).

More recently I attended a Community Meeting yesterday hosted by Granville. Several of my neighbors attempted to make THIS meeting about the proposed shelter. Mr. Assemi, in an attempt to appease them and try to move on, asked how many people opposed the shelter being built: ¾ of the room raised

their hands, until one gentleman said “I do not know enough to form an opinion”. From that experience, I was able to see how many of my neighbors made up their minds before becoming educated on this amazing facility.

With this said, I took pictures from my drive that would be in front of the proposed land so you can have an idea of what traffic would be during Fresno Humane Animal Shelter’s business hours, including what would be the expected busiest day, Saturday. I understand a traffic study has been performed, but I do believe pictures speak a thousand words, so please see below. I have details on the date and time these pictures if you need them. (see section C on next page).

So why have some of my neighbors taken this stand? I feel that this is a move to pick the lowest hanging fruit – a Non-Profit. The Non-Profit does not have money like developers to tie these people up in court. If they had it their way, Fresno would not grow, but somehow would have increased property values. I understand where one of my neighbors is coming from and why he would not want to see the re-zoning happen. However, this project is not a housing development. It is not a prison. It is not a halfway house – it will be an effective and highly respected shelter that has gone above and beyond in fulfilling their promises they have made to you and to the community. I understand you have constituents you have to please, but the time for a politician to take a stand is overdue – in this political climate, can you afford not to take a stand against residents who have ulterior and disingenuous motives?

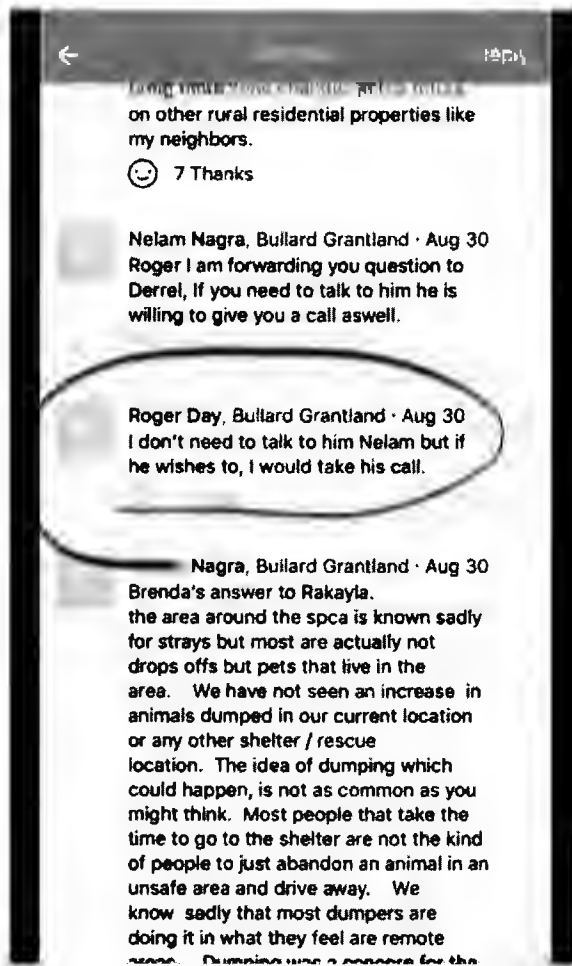

IN AN AREA CURRENTLY DESIGNATED AS RESIDENTIAL**

**SUBJECT: CONCERNS OF MANY CURRENT RESIDENTS OF THE IDENTIFIED AREA,
I.E., THE AREA (ISLAND) BORDERED BY SHAW AVENUE ON THE SOUTH, HERNDON
AVENUE ON THE NORTH AND SANDWICHED BETWEEN GRANTLAND AVENUE AND
GARFIELD AVENUE**

**First of all I, and I assume most folks love animals. It is not a question of “Not in my
Neighborhood.” It is a matter of the following concerns listed.**

CONCERNS:

- 1. Location: is there an architectural design or any schematics available to show the public what this shelter will look like?**
- 2. The quote is that the facility is “State of the Art” at a cost of \$2 million dollars. The building will be built sometime in the future and the cost will change due to rising costs of materials and labor and will the County or donor or tax payers pick up the difference which could amount to millions.**
- 3. Who will pay for the everyday costs of the shelter, i.e., water, electricity, sewer, waste disposal, upgrade of any new pipes for water or sewage, new sidewalks, drains and gutters and any unexpected costs? Will the facility use gas, propane for fuel? Will it be the donor, donations, City, County who will pay these daily costs for years to come.**
- 4. Who will pay and what will happen to providing access to the shelter as there currently are only 2 one way streets on Grantland that have to accommodate not only residents and employees but school population and related traffic. Will medians be torn up and new ones put in. What would that cost?**
- 5. What kinds of animals will be accommodated and how many will the shelter be able to accommodate?**
- 6. Will an environmental impact study be done re air quality and noise pollution, which is needed due to the adjacent school with children and homes across the street on County land.**
- 7. What effect will this building have on property values in the area and especially on those homes on County land across the street?**
- 8. My understanding is that the shelter will be manned by volunteers only.
Which begs the question as to whether this will be 24 hour coverage to provide for animals who may be dropped off at any hour of the day or night.**

It is admirable that the City/County is discussing providing a shelter for animals, but it would be nice if they spent the same amount of time or money on a much needed centrally located Senior Center such as Clovis has or neighborhood parks or infrastructure.

PLEASE NOTE: The current traffic flow is already constricted and gridlocked by only having utilization of Herndon Ave and Shaw Ave to get in and off of this island. The approval to change the zoning from residential to commercial to merely accommodate addition of one commercial building, (namely an animal shelter) and oh yes, Darrells Storage facility, on the south side of Grantland and Freeway 99 South off ramp. Please consider that small corner area is next to a Church, the DANTE Club on Grantland, and the Jehovah's Witnesses Church also on Grantland next to the Herndon Barstow School. The addition of an Animal Shelter along with the additional traffic is not something the residents of our area would enjoy experiencing.

Consider please that there is only one South lane on Grantland Ave that serves the South off ramp to Highway 99.

FIRST RESPONDER ABILITY:

I also worry that the impact of traffic and increased congestion by adding a commercial zoning to our area will impact the ability of first responders in emergencies or mass casualty situation. These are issues we're constantly made aware of daily in the news and now realize these situations can happen anywhere. Just Wed, Sept 19, the nightly the news reported a story about an active shooter situation and lauded first responders response time of 4 minutes. What would be the response time in our area of school or church in a crisis situation. I assume there is plan of action for response.

I and many current residents of the area are not against animals or a shelter for them but wonder about **CONSIDERATION OF THE BOARD OF SUPERVISORS** to put one in such an already traffic congested area previously zoned residential, which is why we bought homes here. Most of our residents have pets and love animals but do not want zoning changed in the area in which they reside which will only add to the traffic congestion and gridlock on a daily basis.

It is also my understanding that an accurate count of daily traffic has not been done since 2010 and the city has not considered, as of yet, the traffic impact on current numbers that have not yet been accrued.

According to information received from Jacob Gentile from the traffic census division for Fresno County "the traffic count at the intersection of Parkway Dr and Grantland Ave has not been done for some time." A study from 2015, more than 3 years ago indicated an ADT of 4900." This is now 2018 and there has been explosive growth and development in this area since then and per Mr. Gentile, "the study data may be obsolete."

The other factor to note is that during peak hours, train schedules that block both Herndon and Shaw Avenues can back up traffic on Shaw Avenue from the tracks to freeway 99 overpass and to the East to Brawley. Herndon will back up past the new Market shopping center and on both the on and off ramps from 99 freeway to Herndon and North Parkway Drive.

The reports and figures previously mentioned are requested by many of our current residents who already feel that the city and county are not interested in helping them alleviate the current congestion. This is another reason to not add an animal services shelter.

IRONICALLY, THERE IS A HUGE BILLBOARD ON HERNDON BEFORE THE RAILROAD TRACK STATING, "DO NOT IDLE YOUR CAR" referring to our air quality.

I would like to know that at least, just this once, the City and County could work together to show they care about our interests and issues on this Island of land between the City and County land. I would appreciate and so would other residents that you provide answers to our questions about the issues that concern us.

Elections do come around, no one is on the Council or Board forever. In the future I would like to be able vote for those who seem to care and are proactive for us and interested only in putting politics or monetary influence by developers or land owners ahead of the interests of your constituents.

I am unable to attend the scheduled Oct 23 meeting on this issue and ask that you consider my concerns when making a decision regarding the future of our neighborhood.

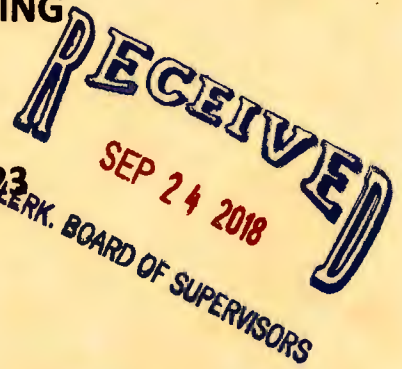

Mr. Pacheco,

My name is Tawnya Keith and I live in the Rio Belleza neighborhood, not far from the proposed site for the new animal shelter. I have been in support of this since it was first proposed many years ago. I've worked with Animal Compassion Team and Fresno Humane for many years as a volunteer and foster mom.

When Fresno Humane took over the County animal control contract the euthanasia rate was over 70% as Liberty Animal Control clearly did not network to actually try to save animals lives. Fresno Humane took over the contract on October 1, 2015 and within 60 days had the euthanasia rate down to 12%. They continue to have high rescue/networking numbers and low euthanasia numbers (some months as low as 4%), not to mention the number of low cost spay/neuters, microchipping and vaccination clinics they've held, and have done so for the 3 years they've had the contract. All this while working out of the parking lot of a condemned morgue.

Speaking of the morgue, this was supposed to be a temporary location for the shelter, yet they are still there 3 years later. Imagine what could be done with a real facility, with more room for animals to be housed, play and be cared for. A state of the art facility that people want to visit to find their next family member. A place where medical treatment can be done on-site to reduce transportation costs and reduce the amount of time an animal has to cope with their illness or injury.

The generous gift from Derrel and Kim Ridenour cannot be overlooked. This is saving the tax payers thousands of dollars, and saving the county millions. They made a similar donation to Animal Compassion Team years ago and look at what they've been able to do: 8,926 adoptions and 1,284 transfers in nine years! This was done without any assistance from

the county, all with private donations and grants. The amazing team of people who run both facilities have such a heart for the homeless pets in our Valley and are truly making a difference.

Some of my neighbors are in opposition of this new proposed site, especially those who live across the street. They've stated concerns such as traffic, abandoned animals, noise and smell. Even when provided with information regarding current traffic at Fresno Humane, details on the layout of the shelter which will reduce noise and smell, and statistics regarding abandoned animals, they are holding their ground, which they have a right to do. Unfortunately, there are a few of them who have become belligerent and downright nasty to those of us who are in support; to the point of a couple who have been removed from the NextDoor app (Gonzalo Arias Jr., Mark Brooks, Elisa Bilios and Stanley Ross to name a few) . Not to mention walking the neighborhoods posting flyers about an upcoming meeting for those opposing the shelter only, on mailboxes and on people's doors (please see attachment for the flyer). One woman, even left her baby in a stroller on the sidewalk, in a driveway, to complete her mission of handing out as many flyers as she could (see attached screen shots of video surveillance). My understanding, which could be incorrect, is that a permit must be obtained to go door to door with flyers, etc. I have yet to confirm they've obtained said permit.

The opposition meeting, which they have a right to hold, is being held at the private residence of Lydia Broussard-Franklin. Lydia has been very vocal about her opposition of the shelter, and has been defaming Derrel by saying she did not get one of the supposed 1,700 flyers Derrel stated he sent out. Those in support have been unable to confirm when or where Derrel made this statement and Lydia only says he did so to the Board of Supervisors. Maybe you recall and can confirm or deny? She has taken it to the point of threatening a discrimination lawsuit against him (see attached), although she doesn't say how she was discriminated against. If the fact that she didn't get a flyer is her basis for discrimination, then I too have been discriminated against as I did not get one of her flyers.

Lydia has even go so far as to start a private Facebook group regarding shelter issues and has told the group that they need to try to get the October 10th public community meeting cancelled because "Derrel continues to be disrespectful and thinks he can bully us" and "He was only to meet with this area to discuss the issues at hand. Instead he invites all of the supporters which we know will outnumber us." She goes on to reiterate that she thinks this is bullying and "it could get downright nasty". She wraps her statement up by insinuating that "We all heard what the Board of Supervisors told him to do and he agreed." Between what she has said publically (slander) and in written form (libel), she is setting herself up for a defamation lawsuit if Derrel was the type of person to do such a thing.

She has also been very vocal about not being notified about any of the meetings and being left out. However, she herself made a post on NextDoor back in May talking about the community meeting with details on when and where. Even with presented with the information about her knowledge back in May, she insists she didn't know. She is spreading lies and vitriol as a way of "educating" people. She has shown that she truly knows the meaning of the word "bully" based on how she has treated others who disagree with her.

I understand the political need to postpone the rezoning vote as there were a number of people who stated they didn't know about the meeting and needed more time to gather information. However, I have seen enough Facebook and NextDoor posts to know they are pulling your leg. They knew a long time ago and have been in cahoots with each other to keep fabricating stories to delay this as long as possible. A couple supporters at the September 11th meeting even overheard Lydia and others telling the rest of those in opposition to state they did not receive notice of the meeting, even if they did.

Please note, this letter is not written with the sole intention of bashing Lydia and the group of opposers, but rather for the purpose of shedding light on the situation as those of us in the neighborhood see it. She will stop at nothing to convince people that this is a bad thing, including lying and threatening people with a lawsuit.

I pray the Board of Supervisors moves forward with the rezoning of this property and allows Derrel to build the new animal shelter for Fresno Humane. Until something else is done regarding backyard breeders, selling animals on the

street or at the Cherry Auction then our only option is to have improved facilities for the unwanted pets of this community to go and have a chance at a better life.

I appreciate the time you've spent reading this letter and hope you take the information contained within into consideration when discussing the topic with the Board of Supervisors and casting your vote. I hope to see you at the community meeting on October 10th.

I am writing to you as a citizen of the city of Fresno and county of Fresno to express my opposition to the rezoning of land between Grantland Avenue and Highway 99. If the vote to rezone comes to pass, a precedent will be set and a slippery slope will allow many more of these kinds of rezoning to occur. In addition to the problems that will be created by the mere allowance of the rezone, the projected plan for that land will cause a multitude of issues for those of us living in the surrounding neighborhoods.

My first and foremost concern is what the shelter will do for the safety and wellbeing of students of Herndon Barstow Elementary. The shelter (as well as the mini-storage that will soon follow) will increase the traffic in front of the school. The current conditions are already extremely dangerous for families who live south of the school and west of Grantland. While there are crosswalks for students to walk between home and school, it requires to cross streets a minimum of two times. One being unmanned at the intersection of Grantland and Bullard. For children who live south of Bullard it would require 3 crossings (2 unmanned). At that point along Grantland the speed limit is 40mph and routinely I have witnessed cars traveling much faster in both directions. With the increasing number of homes this will only get worse and a rezone and subsequent build will compound the issue. These dangers cannot be avoided or reduced due to the lack of sidewalks along the west side of Grantland

Secondly the rezoning to allow the construction of the shelter will bring about stray animals that might also be sick or lame. Those animals will find their way on to school grounds and into the neighborhoods where the children play, live and travel to school. The children of the neighborhood and school should not be subjected to animals in these conditions. Students will suffer negative impacts upon their physical and emotional well-being.

I also want to make it clear that I am not opposed to the idea and need of a new state of the art animal shelter for Fresno County. I am opposed to the rezoning of this particular piece of land in order to place it in that specific location. I am certain that the county has many other possible sites to place the shelter. For example there is plenty of county land near the Juvenile Justice Center close to Highway 99 and American Avenue. That location for example would cause none of the issues described above.

I also understand that Mr. Ridenour is a major reason why this rezone is being considered. I can appreciate the generosity of land and money, but feel that he could still be just as generous at another site. I also understand that he has referenced many comparison sites as examples as to why this will work. I would refute those examples on the ground that none of his comparables are as large of a facilities as this and also none of them are as close to a school as this project is.

I also feel that there might be some information about this whole process that the public is unaware of either intentionally or unintentionally. Many of us in the surrounding neighborhoods never received any notification of the hearings, meetings, etc. Flyers that were supposedly sent out, were not received. Advertisement of this project was done in the cheapest manner possible via the Fresno Business Journal, which many of us do not receive.

So for those of you that are my elected representatives, I need you to represent myself and my neighbors in working to prevent this rezoning and subsequent shelter/mini storage. I have yet to hear a neighbor speak out for this location. I have heard the voices of many supporters, but to my knowledge none live in the area. For the rest of you whom I am not a constituent of I ask you to consider a thought. If this same situation were occurring in your neighborhood, near your children's school, how would you feel and how would your constituents feel?

SECTION 820

"R-R" - RURAL RESIDENTIAL DISTRICT

The "R-R" District is intended to create or preserve rural or very large lot residential homesites where a limited range of agricultural activities may be conducted. The "R-R" District is intended to be applied to areas designated as Rural Residential by the General Plan. The minimum lot size that may be created within the "R-R" District without a special acreage designation shall be two (2) acres. The "R-R" District accompanied by the acreage designation of five (5) establishes that the minimum lot size that may be created within the District shall be five (5) acres.

(Added by Ord. 490.128 adopted 1-11-77; amended by Ord. 490.133 adopted 6-7-77)

SECTION 820.1 - USES PERMITTED

The following uses shall be permitted in the "R-R" District. All uses shall be subject to the property development standards in Section 820.5.

- A. One family dwelling units, not more than one (1) dwelling per lot.
- B. Accessory buildings including servant's quarters, accessory living quarters, garages and farm buildings.
- C. Agricultural crops, greenhouses, fruit trees, nut trees and vines.
- D. Bovine animals, horses, sheep, and goats where the lot area is thirty-six thousand (36,000) square feet or more and provided that the number thereof shall not exceed a number per each thirty-six thousand (36,000) square feet equal to four (4) adult animals in any combination of the foregoing animals and their immature offspring with not more than three (3) adult animals of a bovine or equine kind or combination thereof and their immature offspring or not more than six (6) immature bovine or equine animals or combination thereof where no adult animals are kept per each thirty-six thousand (36,000) square feet. Where the lot is less than thirty-six (36,000) square feet in area, but twenty thousand (20,000) square feet or greater in area, horses may be maintained for personal use in a number not to exceed two (2) animals with their offspring less than one (1) year of age.

(Amended by Ord. 490.191 adopted 12-3-79)

- E. Dogs and cats as domestic pets only (limited to three (3) or fewer animals four (4) months of age or older).

(Amended by Ord. 490.133 adopted 6-7-77)

- F. Home Occupations, Class I, in conjunction with a detached single family residential unit, subject to the provisions of Section 855-N.

(Amended by Ord. T-027-288 adopted 2-25-86)

G. Mobilehome occupancy, not more than one (1) mobilehome per lot, subject to the provisions of Section 856.

H. Signs subject to the provisions of Section 820.5-K.

I. Storage of petroleum products for use by the occupants of the premises, but not for resale or distribution.

J. Storage or parking of boats, trailers, recreational vehicles, or commercial vehicles, limited to the private non-commercial use by the occupants of the premises.

K. The keeping of rabbits and other similar small furbearing animals for domestic use on a lot containing not less than thirty-six thousand (36,000) square feet.

(Amended by Ord. T-038-306 adopted 5-22-90)

L. The maintaining, breeding, and raising of poultry for domestic use not to exceed five hundred (500) birds and the maintaining, breeding, and raising of poultry for FFA, 4-H and similar organizations. In no case shall the poultry facility be kept or maintained on a lot containing less than thirty-six thousand (36,000) square feet.

Seized birds may be held at the shelter facility or at our livestock holding facility near Kearney Park.

FHAS dispatchers entered 213 case activities for the 93723 jurisdiction in 2016, 297 in 2017, and 162 so far in 2018. This is consistently 2.5-3 times more than the average case activities for other jurisdictions.

How many FHAS employees were present at the Fresno County Board of Supervisors Meeting on company time? Were they on paid vacation leave?

FHAS is a contractor to Fresno County. They are fulfilling the requirements of their contract, we do not track how their staff spends their time to fulfill those requirements.

Dear Supervisor Quintero:

I am writing in support of the rezoning of two parcels of land donated to Fresno Humane Animal Services. Due to work obligations, I am unable to attend the meeting on Sept. 11 but hope you will not consider that a reflection of my passion about this issue.

While listening to the meeting of the Planning Commission where this proposal was recommended for approval, it was obvious to me that there wasn't a person in attendance who was not in favor of the tremendous work being done by Fresno Humane. No one said or even inferred that the animals didn't deserve a better facility than the one they currently inhabit in the parking lot of the old Fresno County Morgue. So I won't waste your time trying to convince you of the need for a shelter.

However, I would like to acknowledge and address the concerns that were most often expressed: Noise, smell and traffic.

It is my understanding that Fresno Humane and their project partners have specifically designed the shelter to reduce noise and smell. Their design means all dogs will be indoors at night, putting multiple walls between them and the two homes directly on Grantland Avenue. Every other home in the area will have the additional protection of the homes and other buildings between them and the shelter. It would surprise me if the noise level, even at those two homes, was anything more than dogs in the distance. As for smell, I am routinely over at the current Fresno Humane shelter, and even as close as standing in the parking lot, there is no smell. It only becomes "doggy" over there when you're actually in the kennel area. And even then, it's not the smell of dog waste, it's just the smell of dogs. When you consider the affirmative steps the shelter planners are taking to seal and destroy waste, I can't imagine anyone outside the kennel area at the new shelter will smell anything.

It is worthwhile noting that these were the same concerns expressed when the Fresno Bully Rescue shelter plan was being considered. I'd invite you to search the County's records for complaints about those issues since the shelter opened. It is my understanding complaints have been few, or none.

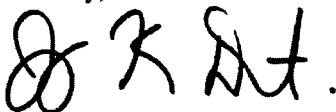
As for traffic in the area, I understand it's becoming a real problem for residents in the area, especially considering new housing and the elementary school located just southwest of the project. However, the studies produced by the County negate the concern that this shelter will add significantly to the problem. The shelter's hours will be limited to avoid adding vehicles during busy hours. Furthermore, an animal shelter isn't a shopping mall: They don't ever have a huge amount of vehicular traffic. The current parking area at Fresno Humane has only a dozen parking spaces, and they are rarely full. Though we would hope for an increase in visitors at the new shelter, I can't believe it's going to increase enough to lead to traffic jams.

The members of the Planning Commission who voted against the rezoning expressed concerns that the location isn't right for a shelter. They spoke of it needing to be more rural, further out of town, not in an area that's zoned residential. Simply stated, they were wrong. The shelter needs to be where people can find it. It needs to be right where the people are, so as to increase awareness and improve the dogs' chances of finding their forever homes. Fresno Humane puts available cats at local PetSmart stores right in the middle of everything, so their chances of being adopted improve. They can't do the same for dogs, who require much more daily care than a retail store can provide. So they need to have a place that is equally accessible and easily found. Putting our homeless animals out of sight puts them out of mind. If we hide our stray animal population, say behind a condemned morgue, it is far easier to ignore them, pretend the problem doesn't exist. For the sake of the animals, and to keep us humans from forgetting their plight, the shelter needs to be front and center.

The bottom line is that Fresno Humane is responsible for the care and control of stray animals in our County, of which there are far too many. The County has seen fit not to provide a decent shelter for those animals awaiting rescue and adoption, leaving it to the non-profit to figure out. Fresno Humane has received this generous donation of land in a place that is well-suited to an animal shelter, and are ready to raise the funds necessary to build it. To deny them the opportunity to make use of this land and to greatly improve the lives of the animals who depend on us because of unfounded fears about noise, smell, and traffic would be unconscionable.

I look forward to hearing the Board approved this zoning amendment.

Good morning Supervisors,

I have looked at a lot of documents that have to do with this rezoning of apn # 504-081-025/03S that you have seen as well I assume. The 55 page document was one sided at best as it was "no impact" or "little impact" and yet it never once mentioned anything about what the immediate neighbors thought about it? Mr. Ridenour posted a notice in the Fresno Business Journal per the requirements of this type of transaction. In the real world, the neighbors in West Herndon Acres do not subscribe nor check listings in that publication. Yes, I asked my neighbors on Menlo, Annapolis, Tenaya, Sample, Garfield, Bullard and Tisha. He did what was required but that requirement is old and needs updating. The "300 foot rule" for notifying of a change in zoning is ludicrous when dealing with acreage lots. My lot is 440 feet wide. He could have been next door to me and I would not have been notified as I still have not by him or FHAS.

The plans went into plan check at the County in June. The planning commission did not hear the case officially until July. That's seems strange to me as the plans were drawn site specific. By the way, I received a full set on 9/10/18 to bid on so I am accurate on my timelines. As a contractor in Fresno for almost 30 years, I think Mr. Ridenour followed the criteria, but he used the system to work in his favor. I have researched Mr. Ridenour and this is his typical MO for his mini storages. He tends to change the zoning frequently and recently even started litigation towards the city of Visalia for not using eminent domain on a homeowner that interfered with his mini storage. Nice guy huh?

Mr. Ridenour called me after the supervisor meeting on 9/11 and told me it is going to happen and I need to accept it. I took issue with that as I was assured by your office you have not decided, yet I feel that once he was directed to speak to the immediate homeowners impacted by his philanthropic gift, he took it as he needed to check the box and he is on his way. That once he had his "meeting", the supervisors would give him the green light. He could not be more wrong from myself and my neighborhoods stand point.

I have fought off 4 previous zone changes to keep our neighborhood just that, a neighborhood of homes. To be able to go to my home after fighting traffic, dealing with problems at work or school and not having to worry about what other rural residential land owner wants to flip their land because M-1 land is worth considerably more than RR. We have enough to deal with as the 76 station thinks it's a truck stop and it seems everyone in Fresno wants to go through the 99/ Herndon overpass.

When Mr. Ridenour was questioned by Supervisor Mendes if he had considered any other site, he responded no. That is because plans are drawn site specific so he will do whatever it takes to get his zoning changed. Animal shelters are classified to be in a commercial/industrial zoning for a reason. Homes are not built in a commercial zoning for similar reasons.

There are a lot of city residents who are praising this project when in fact, it's not a city issue. Although these citizens live close by, they are not your constituents. We are. If it was annexed into the city, my voice would fall on deaf ears. It's not in the city. No one knows for sure if and when it will get annexed in. As I stated before, the city has asked me to join

in when the land gets developed behind my house off of Parkway and Menlo. That was fourteen years ago and they made it sound like it was happening immediately.

I am in Texas right now and drove around to the different cities to see where there animal shelters were. They were ALL located in commercial/industrial areas. In California, I have built and seen dozens and dozens of animal shelters and they are ALL in the same commercial/industrial locations. Why is it that Derrel wants to push this zoning into our neighborhood? Money and write-offs is my guess. Commercial property is more expensive and his write-off is worth more, even though he purchased the land rural residential from Gary McDonald in the late 2000's very cheap because of the economic pit fall. He knew he had to build it in commercially zoned property and after speaking to him personally, he honestly feels and so much as told me he knew what was best for our neighborhood. He truly feels the well being of these animals outweighs the need or rights of the people in our neighborhood. He is dead wrong!

In closing, I urge you, the Supervisors of Fresno County to hear the neighbors and County residents in rejecting this zoning change. A lot of support for the rezone has come from outlying residents who are NOT of this neighborhood. Please listen to the ones that are. Thank you.

Thank you for attending the neighborhood meeting to discuss the proposed animal shelter project on October 10th at the Dante Club. Attached to this email are the sign-in sheet and all surveys that were returned to us. A total of 154 people signed in, but there were quite a few people who declined to list themselves. Actual attendance was probably closer to 200. Only 38 surveys were turned in at the end of the night. Of those, 13 expressed concerns with the project--all live less than a mile from the project site. One survey was neutral. 25 surveys expressed support for the shelter project--12 of those live within a mile of the site. Eight people requested follow-up calls. I reached out to them today and had some good conversations. Going forward, I now have a better understanding of the neighbor's concerns and how we might address them should the rezone be approved.

Primary concern with the project:

I oppose the rezone first and foremost. Too much traffic already and insufficient roads to support it. There is an elementary school too close for comfort. There are far more appropriate places for a shelter elsewhere. When we purchased our homes in this area we did so under the knowledge that a mini storage would be placed there, not a shelter. Re zoning is a slippery slope and decreases property value nearby.

Anything else you'd like us to know:

We NEVER received a notice regarding the first few meetings in May/June or September! Very upset that huge changes are being made without so much as a notice! The City/County keeps passing out permits for buildings but important infrastructure, roads etc take a backseat. We're still waiting on Veteran's Blvd. and over/under passes at Shaw and Herndon.

Dear Mr Pacheco,

I was an animal foster for Animal Compassion Team (ACT). I also did some fostering for Fresno Humane Animal Service after they got the county contract. As a primarily kitten foster, I can tell you that when I found out that the cats and kittens were being housed in a condemned building of the morgue. Because of this volunteers are not able to enter the building so the only human contact they have are the few employees with access to the building. The last two kittens I pulled for fostering came unfortunately had to be my last. One had a horrible upper respiratory infection that caused substantial vision impairment. I had to take her to a specialist to finally get rid of the virus, it took approximately one month. The tiny kitten I brought with her had ringworm. While it is fairly easy to treat, because Frannie(the sight impaired cat) was exposed the special needs rescue in the Bay Area could no longer accept her. I did end up adopting her and the kitten myself, since their illnesses took so long to treat they became bonded to each other and our home.

The plight of the dogs in this make shift shelter needs improving, but the cats situation is really an immediate need. Only cats that are too young or sick to live on their own outside stay in the shelter environment. Volunteers need to have access to these cats and kittens to give them the socialization they need to transition to companion animals

All our valley animals need to have a safe secure place when they find themselves down on their luck. I ask that you please vote yes to rezone the donated property and allow the building of the state of the art new facility.

In addition I hope you will consider changing the city animal control contract from the spca to the experienced, proven staff of FHAS.

Dear County Supervisors: Brian Pacheco, Andreas Borgeas, Sal Quintero,

Buddy Mendes, and Nathan Magsig

The proposed rezone site near Herndon-Barstow School is in a currently traffic constricted area and will contribute further to this problem we face daily. The traffic flow and commuters are restricted by only having two egresses over 99, W. Shaw & W. Herndon. This also directly impacts Emergency Medical Services in response to emergencies. Our infrastructure is outdated and no life-line is being thrown to the NW Fresno-District 2 residents. The approval of such an addition, namely an animal shelter, is proposed on Grantland Ave near the Hwy 99 South ramp (single lane), next to the Dante Club, next to and across the street from two churches and County residential homes, which will undoubtedly add to the current traffic congestion.

The project will effect Herndon-Barstow Elementary School in several ways:

- It will make an already horrendous traffic situation worse.
- I personally pick up my grandkids at Herndon-Barstow. For the past two years, I witnessed bottleneck traffic continuously through the area near the school as well as people driving way over the speed limit. Just the other day, CHP stopped a woman who was barreling through the area at 55 MPH when school was letting out. This is an ongoing issue in the school zone area and on leaving or approaching this area.

- Because people oftentimes drop off their unwanted pets at animal shelters after hours, the location of the project adjacent to a school raises serious safety concerns.

I encourage you cast a NO vote on rezoning the aforementioned issue for the safety and well-being of the students at Herndon-Barstow.
