WHEREAS, the Information Technology Services Department Org 8905 will receive \$500,000 from the Local Assistance Fund Org 1034 for the remodel expenses associated with moving the Emergency Operations Center into Pontiac Building 6; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2024-25 Information Technology Services Department Org 8905; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote by the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Information Technology Services Department Org 8905 as follows:
