RESOLUTION AUTHORIZING THE  
FRESNO COUNTY CLERK/REGISTRAR  
OF VOTERS TO CONDUCT THE  
ELECTION AND BILL FOR  
REIMBURSEMENT OF COSTS

WHEREAS, California Elections Code §10002 permits the governing board of a city or district to adopt a resolution requesting a county's board of supervisors to permit the county elections official to render services relating to the conduct of an election; and

WHEREAS, California Elections Code §10002 requires the city or district to reimburse the county in full for the services performed by the county elections official upon presentation of a bill to the city or district; and

WHEREAS, the Fresno County Clerk/Registrar of Voters is the county elections official in Fresno County (“County”); and

WHEREAS, on February 6, 2018, the Board of Supervisors approved the City of Fresno’s (“City”) request in the City’s Resolution Number 2017-317 for the Fresno County Clerk/Registrar of Voters to perform the City’s elections functions for its general and special municipal elections upon written notification from the City Council to the Fresno County Clerk/Registrar of Voters and the Board of Supervisors; and

WHEREAS, in Resolution Number 2017-317 the City consents to reimburse the County for all costs incurred by the County for conducting all municipal elections, including special municipal elections, for the City; and

WHEREAS, on December 12, 2024, the City adopted Resolution Number 2024-299 declaring a vacancy in the office of Councilmember for District Five effective January 7, 2025 and calling a March 18, 2025 Special Municipal Election to fill the vacancy for the remaining term of office of Councilmember for District Five; and

WHEREAS, in Resolution Number 2024-299 the City requests the County Clerk/Registrar of Voters to perform the necessary tasks to complete the March 18, 2025 Special Municipal Election and confirms the City's intent to pay the County for the election services it performs.

**NOW, THEREFORE, BE IT RESOLVED:**

1. The Board of Supervisors authorizes the Fresno County Clerk/Registrar of Voters to conduct the City's March 18, 2025 Special Municipal Election to fill a vacancy for the remaining term of office of Councilmember for District Five, as called by the City in its' Resolution Number 2024-299, adopted on December 12, 2024.
2. The Board of Supervisors authorizes the County Clerk/Registrar of Voters to bill the City for the total costs of the City's March 18, 2025 Special Municipal Election and the City to reimburse the County for such costs.
