WHEREAS, the Sheriff-Coroner's Organization 3111 will receive \$76,651 from the Fresno Unified School District (DISTRICT) to offset expenditures associated with adding one Deputy Sheriff; and

WHEREAS, \$76,651 is not included in the appropriations and estimated revenues of the Sheriff-Coroner's Org 3111 for Fiscal Year 2017-18; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Sheriff-Coroner's Org 3111 as follows:

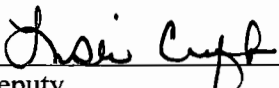
