WHEREAS, the County of Fresno will receive approximately \$82,000,000 from the United States Department of Treasury (US Treasury) Coronavirus Aid, Relief, and Economic Security Act, Coronavirus Relief fund and

WHEREAS, said monies are not included in the FY 2019-20 appropriations and estimated revenues of the Auditor-Controller/Treasurer-Tax Collector Organization 1031; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Auditor-Controller/Treasurer-Tax Collector Organization 1031 as follows:


