WHEREAS, the Sheriff (Org) 3111 will receive \$135,720 as Operating Transfer In from the Sheriff Special Revenue Fund 0095, Sheriff HIDTA-Asset Forfeiture Org 1462, Local Revenue Fund 0271, COPS Front Line Services Org 31190100 and Local Revenue Fund 0271, COPS Sheriff Detention Org 31190200; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Sheriff's Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Sheriff's ORG 3111 as follows:
