1. Fully describe the product(s) and/or service(s) being requested.

The County of Fresno, Department of Behavioral Health (DBH) intends to execute a Master Agreement with various licensed facilities certified to provide placements and specialized residential services for seriously emotionally disturbed (SED) youth with severe and persistent mental health conditions pursuant to Welfare Institutions Code (WIC) and California Code of Regulations (CCR). Providers located in Fresno and out-of-county would be part of the executed Master Agreement. Services include Psychiatric Health Facility, Mental Health Residential Treatment, Parital Hospitalization, Intensive Outpatient Program services, Community Treatment Facility services, and Day Treatment - Intensive Services.

3. What is the total cost of the acquisition? If an agreement, state the total cost of the initial term and the amounts for potential renewal terms.

The acquisition will not result in an increase in Net County Cost.

4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.

The contracted providers listed above are licensed to provide placement and specialized residential mental health services for SED youth with severe and persistent menal health conditions. Youth placed to facilities under this agreement are conserved or foster youth. These facilities serve hard to place youth with high treatment needs.

The majority of youth specialized residential facilities are located outside of Fresno County. Local placements are sought first, however, out-of-county placements are often necessary to ensure the proper level of care.

Residential facilities specializing in youth placement are able to sustain themselves through patient fees and private insurance. They do not rely on Medi-Cal for revenue. For that reason, these facilities are typically unwilling to respond to County requests such as procurements.

6. Explain why the unique qualities and/or capabilities described above are essential to your department.

The proposed agreement would be for a higher level of care for conserved persons. The need for these services has been increasing annually and it is necessary for the department to expand our network of specialized residential facilities to meet the needs of the people of Fresno County, espically for youth. This agreement allows for the funding of services for undocumented and unfunded clients.

7. Provide a comprehensive explanation of the research done to verify that the recommended vendor is the only vendor with the unique qualities and/or capabilities stated above. Include a list of all other vendors contacted, what they were asked, and their responses.

The County is required by WIC, Section 500 et seq. and CCR, Sections 72001, et seq. to provide placement and specialized residential mental services for SED youth with severe and persistent mental health conditions. The Department of Behavioral Health has received an increasing number of referrals from local hospitals seeking emergency placement for SED youth with severe mental illness (SMI). In order to identify facilities qualified and capable of meeting the specific clinical needs of the referred individuals, the Department of Behavioral Health's Conservatorship Team reached out to the facilities and inquired about the services offered and the populations served at their locations. The facilities that are added to this master agreement are able to serve very high need youth that have hard to treat disorders and educational needs. The two facilities mentioned above have made it through the vetting process by the Conservatorship team and have been identified as providing adequate and quality services.

The two facilities above are currently on the Specialized Residential Mental Health Services Master Agreement. DBH has not had any issues with the facilities during the current agreement. If any other facilities are identified as a good fit for a conserved or foster youth through the referral process DBH will add them to this master agreement.
