RESOLUTION NO. 2024-01

BROADVIEW WATER DISTRICT

**A RESOLUTION OF THE BOARD OF DIRECTORS
CALLING THE 2024 DISTRICT SPECIAL ELECTION
AND AUTHORIZING REQUIRED ACTIONS**

WHEREAS, the terms of office for two elected members on the Board of Directors (Board) of Broadview Water District (District) are vacant or have expired; and

WHEREAS, the terms of office for three positions on the Board of Directors filled by appointment or vacant shall be filled by the persons elected at the next general election; and

WHEREAS, California Water Districts law and California Elections law prescribe the time and manner for the conduct of the election to fill these elective offices, including the use of an all-mail ballot; and

WHEREAS, the California Elections law provides that forms for declaration of candidacy shall be first available on the 113th day prior to the election and shall be filed no later than 5 p.m. on the 88th day prior to the election; and

WHEREAS, the California Elections law provides that a candidate may prepare and file with the elections official a candidate's statement, as prescribed, and that the District may estimate and collect from the candidate the total cost of printing, handling, translating and mailing such statement; and

WHEREAS, the California Water District law prescribes that if an equalized assessment book of the District does not exist, each voter shall have one vote for each acre of land, or fraction thereof, owned by the voter in the District, and that the last assessment roll of Fresno County shall be used in lieu of the assessment book of the District as evidence of ownership; provided, that the Board may authorize correction of the assessment book to reflect those persons who as of the 45th day prior to the election appear as owners on the records of Fresno County; and

WHEREAS, the California Elections law prescribes the duties and responsibilities of the District, as well as those of the county clerk if requested by the District; and

WHEREAS, the Secretary of the District is best informed and suited to perform the duties prescribed by the election laws and it is in the District's best interest that the Secretary be authorized.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED as follows:

1. In the event that the number of nominees exceeds the number of positions on the Board of Directors that are to be filled by election this year and an election is required, such election shall be held on the last Tuesday of August, that day this year being August 27, 2024.

2. Such election, if required, shall be conducted pursuant to the all-mail ballot procedure authorized and described in the California Elections laws.

3. Forms for declarations of candidacy shall be available from the Secretary of the District at the District's Office on or after May 6, 2024, and shall be filed not later than 5 p.m. on May 31, 2024, in the same office; provided, that forms may be filed by certified mail so that the forms reach the District's office no later than the deadline for filing in person.

4. If a candidate for election files a statement of qualifications for inclusion in the voter pamphlet, the candidate shall pay, at the time of filing said statement, the cost of printing, handling, translating, and mailing the statement, estimated to be \$350.00.

5. The list of voters for this election shall be prepared based upon the last assessment roll of Fresno County, corrected to reflect, as of the 45th day prior to the election, those persons who as of that date appear as owners on the records of Fresno County.


6. The Secretary of the District is authorized and directed to take any and all actions necessary in order to properly and efficiently conduct the election pursuant to and in compliance with the California Water Districts law and the California Elections law.

BOARD OF DIRECTORS TO RECEIVE UPDATE ON PARCELS OWNED BY BROADVIEW WATER DISTRICT


