WHEREAS, California Election Code section 10002, permits the governing board of a city or district to approve and execute a resolution requesting a county's board of supervisors to permit the county elections official to render services relating to the conduct of an election; and

WHEREAS, California Elections Code section 10400 et. seq., and other state laws permit consolidation of elections and sharing of election costs by cities, counties, school districts, other public districts, and other public entities by order of the County Board of Supervisors; and

WHEREAS, the Fresno County Clerk/Registrar of Voters is the county elections official in Fresno County; and

WHEREAS, Golden Plains Unified School District adopted Resolution Number 15-16-05 on July 21, 2015, requesting the Fresno County Clerk/Registrar of Voters conduct the April 12, 2016 special election and consolidate with any election also ordered to be held on April 12, 2016; and

WHEREAS, Raising City Elementary School District adopted Resolution Number 85-2015 on December 10, 2015, requesting the Fresno County Clerk/Registrar of Voters conduct the April 12, 2016 special election and consolidate with any election also ordered to be held on April 12, 2016.

NOW, THEREFORE, BE IT RESOLVED:

1. The Board of Supervisors authorizes the Fresno County Clerk/Registrar of Voters to conduct the April 12, 2016 Golden Plains Unified School District and Raisin City Elementary School District elections.


- 1           2. The Board of Supervisors orders the consolidation of the Golden Plains Unified School  
2           District and Raisin City Elementary School District elections on April 12, 2016.
- 3           3. The Board of Supervisors authorizes the County Clerk/Registrar of Voters to bill Golden  
4           Plains Unified School District and Raisin City Elementary School District for all costs  
5           related to the conduct of the April 12, 2016 Consolidated School and School Recall  
6           Special Election.


