ORDINANCE NO. 18-002

AN ORDINANCE AMENDING SECTION 2.08.060 AND REPEALING SECTION 2.08.090 OF TITLE 2, CHAPTER 2.08 AND ENACTING NEW SECTION 2.04.040 OF TITLE 2, CHAPTER 2.04 RELATED TO THE CLERK OF THE BOARD OF SUPERVISORS.

The Board of Supervisors of the County of Fresno ordains as follows:

SECTION 1: Section 2.08.060 of Title 2, Chapter 2.08 of the Fresno Ordinance Code is amended to read:

"2.08.060 – Officer functions – Limitation.

No provision of this chapter is intended to vest in the county administrative officer or the county administrative office any duty, prerogative or discretion now conferred by law upon any other officer of the county and it shall not be so construed. It is the intent of the board of supervisors only to establish an administrative officer and a county administrative office and prescribe the prerogatives, duties, powers, responsibilities and functions thereof in order to assure a high degree of efficiency and economy in the purely administrative operation of the government of Fresno County."

SECTION 2: Section 2.08.090 of Title 2, Chapter 2.08 of the Fresno Ordinance Code entitled **"2.08.090 – Clerk of the board of supervisors."** is repealed in its entirety.

SECTION 3: New Section 2.04.040 is enacted and included in Title 2, Chapter 2.04 of the Fresno Ordinance Code to read as follows:

"Clerk of the Board of Supervisors.

The Clerk of the Board shall be appointed by and report to the Board of Supervisors and shall have and perform all powers and duties otherwise conferred by law upon the county clerk as clerk of the board of supervisors. With respect to any person appointed to the position of Clerk of the Board by the Board of Supervisors after the effective date of this section, the appointment shall be at will, and the Clerk of the Board shall serve at the pleasure of the Board of Supervisors."

SECTION 4: This Ordinance shall take effect and be in force and effect 30 days from its adoption.

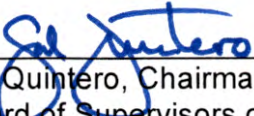
