In the Matter of Establishing the Appropriations Limits for Fresno County Waterworks Districts Nos. 37, 38, 40, and 41 for Fiscal Year 2024-25	Resolution

**WHEREAS**, under Article XIII B, section 1, of the State Constitution, the total annual appropriations subject to limitation of each County Waterworks District shall not exceed the appropriations limit of that County Waterworks District for the prior year adjusted for the change in the cost of living and the change in population, except as otherwise provided in Article XIII B of the State Constitution; and

**WHEREAS**, Government Code section 7910 requires the governing body of each local jurisdiction to annual establish by resolution its appropriations limit for the following fiscal year under Article XIII B of the State Constitution at a regularly scheduled meeting or noticed special meeting; and

**WHEREAS**, the governing body of Fresno County Waterworks District Nos. 37, 38, 40, and 41 (each a "District," and collectively, "Districts") is the Board of Supervisors for the County of Fresno sitting as the Board of Directors for each District ("Board"); and

**WHEREAS**, the base year appropriations limit for the Districts, for Fiscal Year 1986-87, were as stated in Attachment A to this resolution; and

**WHEREAS**, each fiscal year since the base year, the Board has established the appropriations limit for the Districts as required by Government Code section 7902, so that the appropriations limit of each District in each fiscal year is equal to the appropriations limit for that District for the prior fiscal year multiplied by the product of the change in cost of living, and the change in population for the calendar year preceding the beginning of the fiscal year for which the appropriations limit is determined, and adjusted for other changes required or permitted by Article XIII B of the California Constitution; and

1           **WHEREAS**, the appropriations limits for the District, for Fiscal Year 2023-24, were as  
2 stated in Attachment A to this resolution; and

3           **WHEREAS**, the County's Department of Public Works and Planning administers the  
4 Districts and provided the information necessary to calculate the appropriations subject to limit  
5 for each of the District, including estimated proceeds of taxes for Fiscal Year 2024-25; and

6           **WHEREAS**, for at least 15 days before the date of this resolution, documentation used  
7 in the determination of the appropriations limits for the Districts for Fiscal Year 2024-25 was  
8 available for public inspection in the office of the Clerk of the Board and the office of the Auditor-  
9 Controller/Treasurer-Tax Collector; and

10           **WHEREAS**, before adopting this resolution, the Board gave the public, including any  
11 affected taxpayers, the opportunity to present any evidence or testimony for or against the  
12 Board taking such action;

13           NOW, THEREFORE, BE IT RESOLVED:

14           1.       Under Government Code section 7901, subdivision (b), the Board selects the  
15 change in population within Fresno County as the "change in population" factor used in the  
16 calculation of the appropriations limit for the Districts for Fiscal Year 2024-25.

17           2.       The appropriations limit for each District for Fiscal Year 2024-25 is established as  
18 stated in Attachment A to this resolution.

19           3.       This resolution is effective immediately upon adoption.
