8 WHEREAS, Senior Deputy District Attorney, Susan Rand, retired on September 30,
9 2023; and

10 WHEREAS, the District Attorney will have a vacant Senior Deputy District Attorney
11 position; and

12 WHEREAS, Susan Rand has an extensive background with over twenty-five years of
13 County experience as an attorney. This experience has given her a unique understanding of
14 the District Attorney’s Office and California law, with extensive knowledge in juvenile
15 prosecution and calendar management; and

16 WHEREAS, Government Code section 7522.56 requires a one-hundred eighty (180) day
17 separation period, as established by the California Public Employees’ Pension Reform Act,
18 unless the employer’s governing body finds and certifies the nature of the employment and
19 that the appointment is necessary to fill a critically needed position before the one-hundred
20 eighty (180) day separation period has passed.

21 NOW, THEREFORE, BE IT RESOLVED, that the Fresno County Board of Supervisors
22 hereby adopts this Resolution to hire extra-help retiree Susan Rand on an as-needed basis,
23 effective October 30, 2023, finding and certifying that the provisions of Government Code
24 section 7522.56 requiring a one-hundred eighty (180) separation period for retired employees
25 returning to employment as extra-help are not applicable to Ms. Rand, because of the nature
26 of Ms. Rand’s employment and her appointment is necessary to fill a critically-needed position
27 before 180 days has passed following the date of Ms. Rand’s retirement.




