RESOLUTION

WHEREAS, the Sheriff-Coroner-Public Administrator's Organization 3111 will receive \$49,924 as an Operating Transfer In from the Sheriff-Coroner Special Revenue Fund 0095, Sheriff Automated GC 26731 Subclass 17654 Sheriff Automated GC Org 1455; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Org 3111-2401; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Sheriff Organization 3111 as follows:


