A public hearing will be held on **TENTATIVE TRACT MAP NO. 5239 – TIME EXTENSION** filed by **BRATTON INVESTMENTS**, proposing to:

Grant a 24-month time extension for Tentative Tract Map No. 5239, originally approved in 2008, which authorizes the creation of 41 single-family residential parcels with a 2-acre minimum parcel size in the R-R (Rural Residential) Zone District. The subject property is located on the east side of Auberry Road between Caballero Road and Green Meadow Road, approximately 9 miles northeast of the city limits of the City of Clovis (SUP. 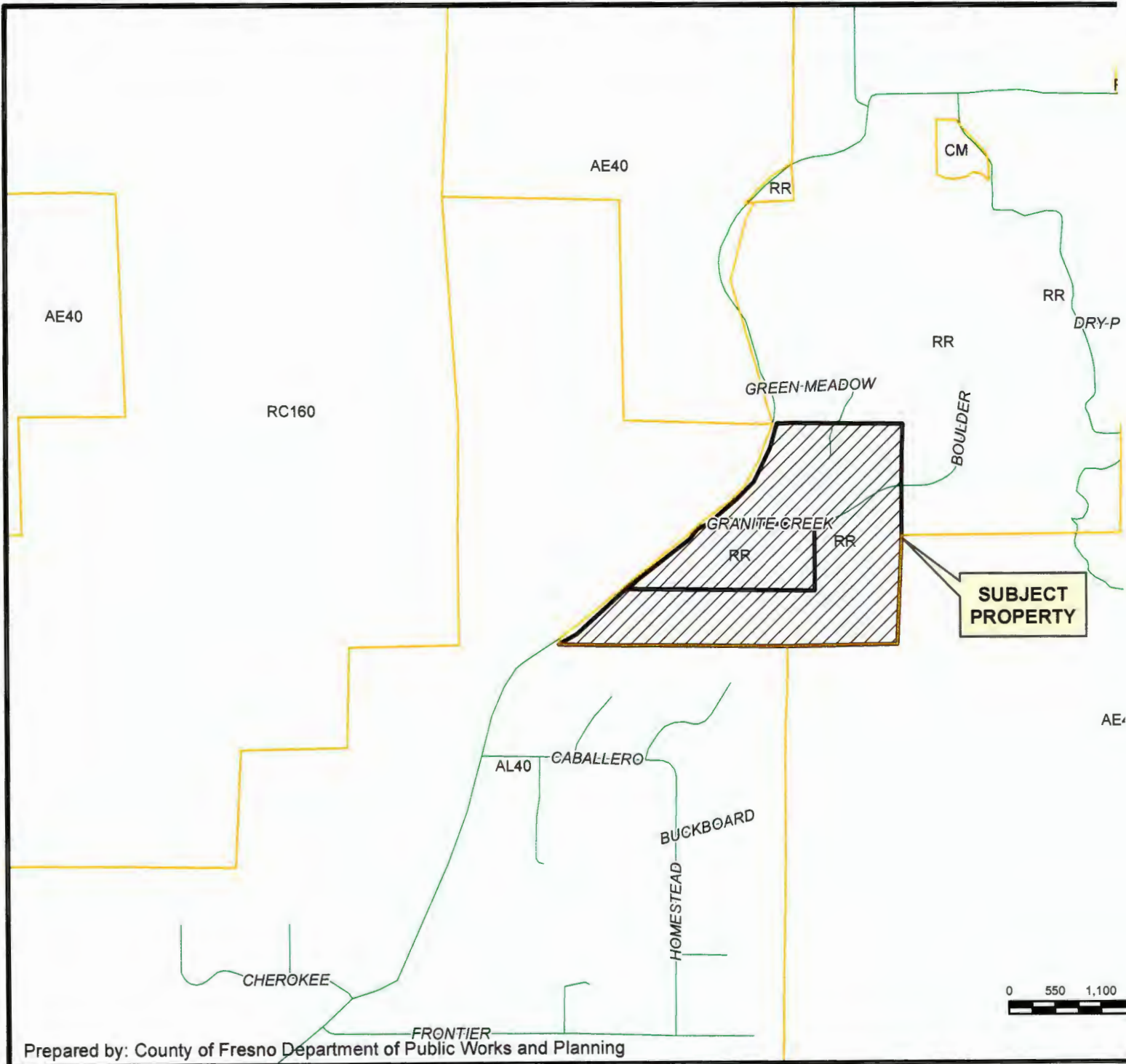

EXISTING ZONING MAP

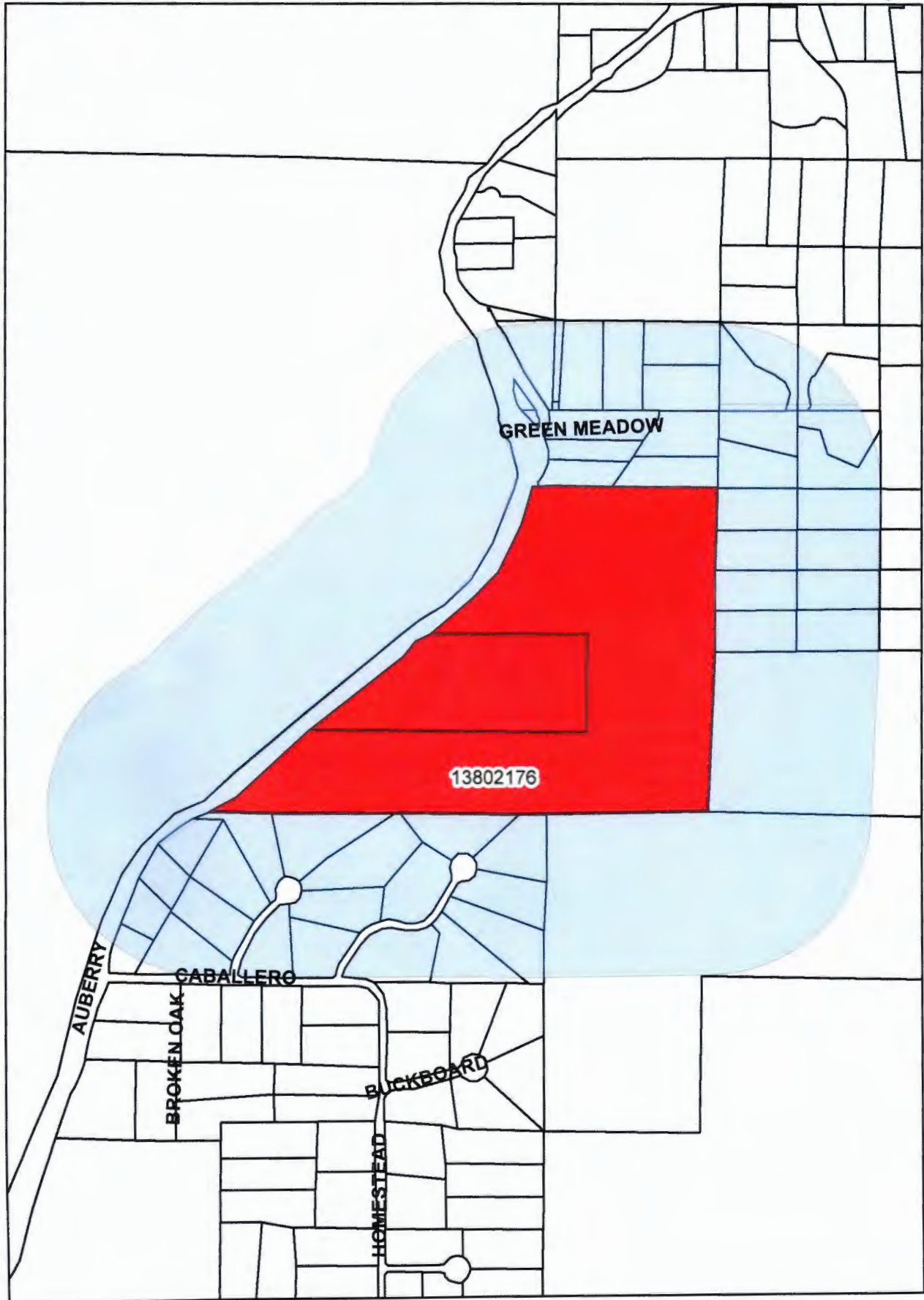

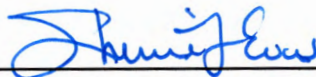
